# The Remuneration of Teachers (Further Education) Order 1978

*Made* - - - 27th September 1978

Coming into Operation 28th September 1978

### Whereas-

- (1) In pursuance of section 1 of the Remuneration of Teachers Act 1965(a) ("the Act") a committee ("the Committee") has been constituted for the purpose of considering the remuneration payable to teachers in all establishments of further education (within the meaning of the Further Education Regulations 1975(b)) maintained by local education authorities and to other further education teachers on the staff of such authorities (except teachers seconded to bodies which reimburse the employing authorities the amount of their salaries) ("further education teachers");
- (2) in pursuance of section 2(2) of the Act, the Committee have transmitted to the Secretary of State for Education and Science ("the Secretary of State") certain recommendations agreed on by them with respect to the remuneration of teachers of the description aforesaid;
- (3) in pursuance of section 2(3) of the Act, the Secretary of State has prepared a draft document setting out the scales and other provisions required for determining the remuneration of teachers of the description aforesaid in the form in which, in his opinion, those scales and provisions should be so as to give effect to the recommendations;
- (4) the Secretary of State, as required by section 2(4) of the Act, has consulted the Committee with respect to the draft document and made such modifications thereof as were requisite for giving effect to representations made by the Committee; and
- (5) the Secretary of State has arranged for a document setting out the requisite scales and other provisions in the form of the draft as modified as aforesaid to be published by Her Majesty's Stationery Office on 27th September 1978 under the title "SCALES OF SALARIES FOR TEACHERS IN ESTABLISHMENTS FOR FURTHER EDUCATION, ENGLAND AND WALES, 1978".

Now, therefore, the Secretary of State, in pursuance of sections 2(4) and 7(2) and (3) of the Act, hereby orders as follows:—

## Citation and commencement

1. This Order may be cited as the Remuneration of Teachers (Further Education) Order 1978 and shall come into operation on 28th September 1978.

## Interpretation

2. The Interpretation Act 1889(a) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament; and section 38(2) (effect of repeals) of that Act shall have effect in relation to the Orders specified in the Schedule as if they were enactments repealed by an Act.

### Remuneration of teachers

3. The remuneration payable from 1st April 1978 to full-time further education teachers shall be determined in accordance with the scales and other provisions set out in the document published by Her Majesty's Stationery Office as aforesaid.

### Revocation

4. The Orders specified in the Schedule to this Order are hereby revoked.

## **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This Order brings into operation the scales and other provisions relating to the remuneration of full-time teachers in all establishments of further education (within the meaning of the Further Education Regulations 1975) maintained by local education authorities and of other such further education teachers on the staff of such authorities (except teachers seconded to bodies which reimburse the employing authorities the amount of their salaries) set out in a document published by Her Majesty's Stationery Office. This document gives effect to recommendations agreed by the Committee constituted under the Remuneration of Teachers Act 1965 for the consideration of the remuneration of such teachers.

The Order has retrospective effect from 1st April 1978 by virtue of section 7(3) of the Remuneration of Teachers Act 1965.
