## TELEGRAPHS

**The Wireless Telegraphy (Broadcast Licence Charges & Exemption) (Amendment) Regulations 1978**

*Made* - - - - 23rd November 1978  
*Laid before Parliament* 24th November 1978  
*Coming into Operation* 25th November 1978

The Secretary of State, in exercise of the powers conferred by section 2(1) of the Wireless Telegraphy Act 1949(a) as enacted, and also as extended by the Wireless Telegraphy (Channel Islands) Order 1952(b) and the Wireless Telegraphy (Isle of Man) Order 1952(c) and now vested in him(d), and of all other powers enabling him in that behalf, hereby, with the consent of the Treasury, makes the following Regulations:—

1. These Regulations may be cited as the Wireless Telegraphy (Broadcast Licence Charges & Exemption) (Amendment) Regulations 1978 and shall come into operation on 25th November 1978.

2.—(1) In these Regulations, “the principal Regulations” means the Wireless Telegraphy (Broadcast Licence Charges & Exemption) Regulations 1970(e), as amended(f).

(2) The Interpretation Act 1889(g) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.

3. The principal Regulations shall be amended by substituting in the third column of Schedule 3 to those Regulations—

- (a) for “£9”, in all four places, “£10”; and  
(b) for “£21”, in all four places, “£25”.

4. The Wireless Telegraphy (Broadcast Licence Charges & Exemption) (Amendment) Regulations 1977(h) are hereby revoked.
