Scheme 1978 Confirmation Instrument 1978

Made - - - - 4th July 1978

The Secretary of State for Transport makes this Instrument in exercise of powers conferred by section 3 of the Highways (Miscellaneous Provisions) Act 1961(a) and now vested in him (b) and of all other enabling powers:—

1. The Devon County Council (Barnstaple, Rolle Street Bridge) Scheme 1978 is hereby confirmed without modifications.

2. The said Scheme as confirmed (hereinafter referred to as “the Scheme”) is set out in the Schedule hereto and copies of the Scheme with its accompanying plans are deposited at the offices of the Department of Transport, St. Christopher House, Southwark Street, London SE1 0TE and at the offices of the County Council of Devon at the Area County Secretary’s Office, Civic Centre, Barnstaple, Devon.

3. The Scheme will become operative on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 to the Highways Act 1959.

4. This Instrument may be cited as the Devon County Council (Barnstaple, Rolle Street Bridge) Scheme 1978 Confirmation Instrument 1978.

THE SCHEDULE

THE DEVON COUNTY COUNCIL (BARNSTAPLE, ROLLE STREET BRIDGE) SCHEME 1978

The County Council of Devon (hereinafter referred to as "the Council") make this Scheme in exercise of their powers under Section 3 of the Highways (Miscellaneous Provisions) Act 1961 and of all other enabling powers:—

1. The Council are authorised to reconstruct over the navigable waters of the River Yeo the bridge specified in the Schedule to this Scheme as part of the highway which they are proposing to improve between Rolle Street on the north-western bank of the River Yeo and the junction of Rolle Street with North Walk, with High Street and with Boutport Street on the south-eastern bank of the River Yeo which said junction is known as Mermaid Cross all at Barnstaple in the District of North Devon in the County of Devon.

2. This Scheme may be cited as the Devon County Council (Barnstaple, Rolle Street Bridge) Scheme 1978.

THE SCHEDULE TO THE SCHEME

PLANS AND SPECIFICATIONS OF THE BARNSTAPLE, ROLLE STREET BRIDGE

Plans of the bridge

In relation to the surrounding area the bridge is located between the north-western and the south-eastern banks of the River Yeo and generally along the same route as the existing bridge over that route all as shown on Plan number B.BA(8)/7/1 and Plan Number B.BA(8)/9 attached hereto and incorporated into this Schedule.

Specifications of the bridge

The Scheme involves construction of a two span (each span being 11.4 metres) simply supported deck of pre-cast pre-stressed concrete shear key beams with two reinforced concrete abutments faced with masonry to match the existing quay walls, a reinforced concrete central pier with no masonry, all having spread foundations, the available clear span of each of the two waterways being 10.6 metres all as shown on Plan Number B.BA(8)/7/1 and Plan Number B.BA(8)/9 attached hereto and incorporated into this Schedule.
