**The Suffolk County Council (A146 Beccles Bypass—
River Waveney Bridge) Scheme 1978 Confirmation
Instrument 1979**

Made - - - - 23rd October 1979

The Minister of Transport makes this Instrument in exercise of powers conferred by section 3 of the Highways (Miscellaneous Provisions) Act 1961(a) and now vested in him(b), and of all other enabling powers:—

1. The Suffolk County Council (A146 Beccles Bypass—River Waveney Bridge) Scheme 1978 is hereby confirmed without modifications.

2. The said Scheme as confirmed (hereinafter referred to as “the Scheme”) is set out in the Schedule hereto and copies of the Scheme with its accompanying plans are deposited at the offices of the Department of Transport, St. Christopher House, Southwark Street, London SE1 0TE, and at the offices of the County Council of Suffolk at County Hall, Ipswich.

3. The Scheme will become operative on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 to the Highways Act 1959(c).

4. This Instrument may be cited as the Suffolk County Council (A146 Beccles Bypass—River Waveney Bridge) Scheme 1978 Confirmation Instrument 1979.

SCHEME 1978

The Suffolk County Council (hereinafter referred to as "the Council") make this scheme in exercise of their powers under section 3 of the Highways (Miscellaneous Provisions) Act 1961 and of all other enabling powers:

1. The Council are authorised to construct over the navigable waters of the River Waveney the bridge specified in the Schedule to this scheme as part of the highway which they are proposing to construct between Gillingham in the County of Norfolk and North Cove in the County of Suffolk.

2. This scheme may be cited as the Suffolk County Council (A146 Beccles Bypass-River Waveney Bridge) Scheme 1978.

THE SCHEDULE TO THE SCHEME
PLANS AND SPECIFICATIONS OF THE A146 BECCLES BYPASS-

SPECIFICATION

Location

The bridge will be situated approximately 332 metres (1,089 feet) due north of the existing "Beccles Bridge" as shown on Plan A annexed hereto sealed by the Council and marked "The Suffolk County Council (A146 Beccles Bypass-River Waveney Bridge) Scheme 1978".

Spans

The total length between abutments will be 64.40 metres (211 feet) measured along the bridge centre line comprising:

1 No. span of 36.00 metres (118.1 feet)

2 No. spans of 14.50 metres (47.6 feet)

as shown on Plan B and Plan C annexed hereto sealed by the Council and marked "The Suffolk County Council (A146 Beccles Bypass-River Waveney Bridge) Scheme 1978".

Headway

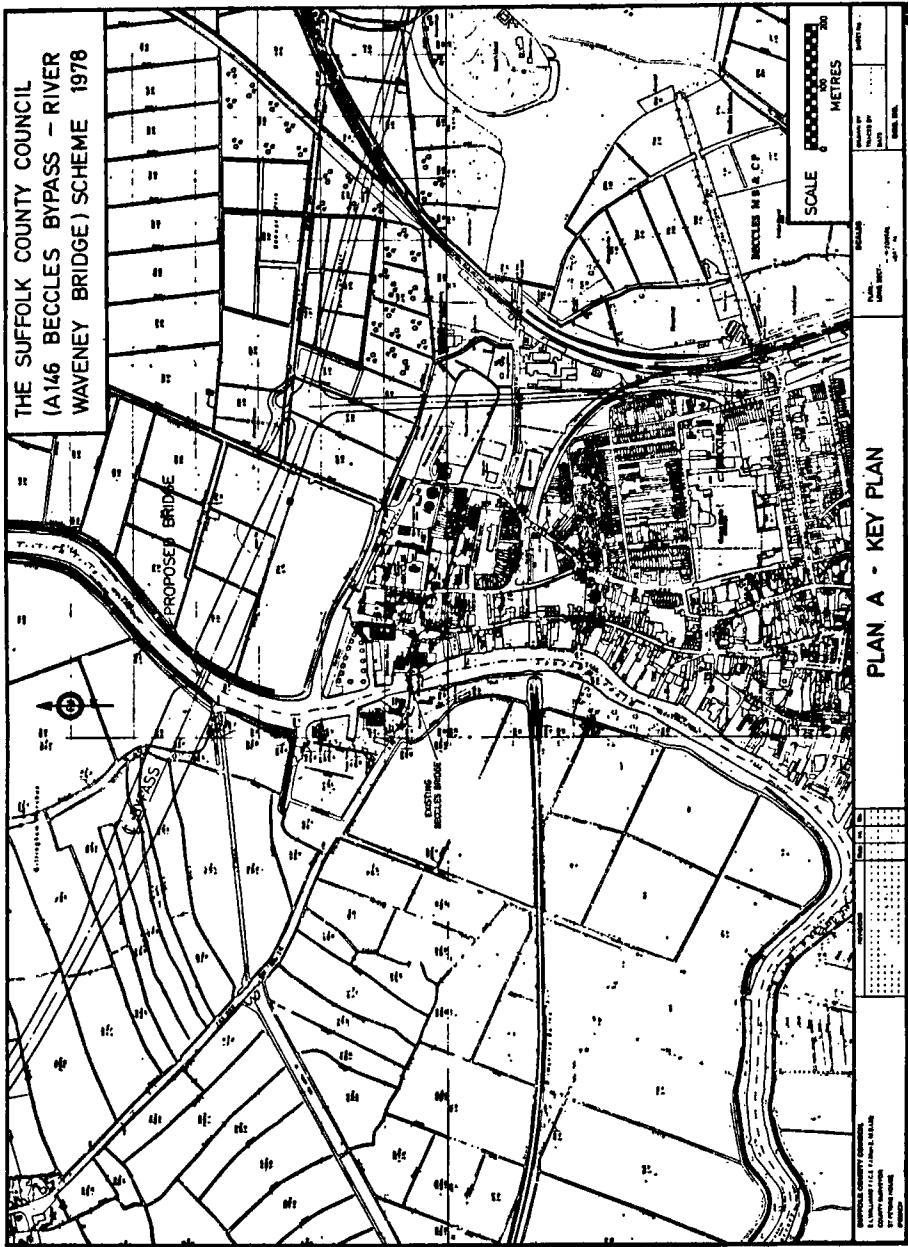
3.32 metres (10.89 feet) above high water ordinary spring tide (0.760 metres A.O.D.) at banks and 3.66 metres (12.00 feet) above high water ordinary spring tide (0.760 metres A.O.D.) at the centre of the bridge as shown on the said Plan C annexed hereto.

Waterway

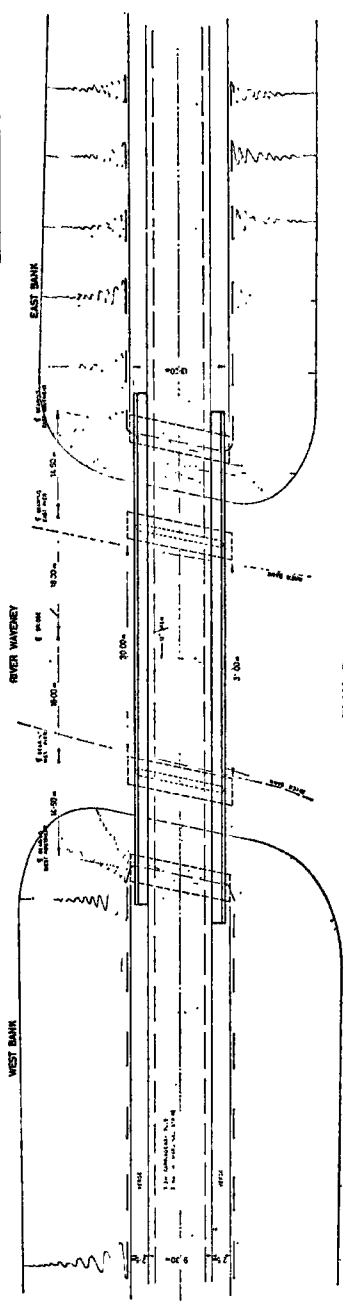
Minimum square waterway will be 29.00 metres (95.1 feet) approximately as shown on the said Plan B and Plan C annexed hereto.

Width

The square width of the bridge will be 13.20 metres.
