LOCAL GOVERNMENT, ENGLAND AND WALES

The Local Government, Planning and Land Act 1980 (Commencement No. 2) Order 1980

Made - - 9th December 1980

The Secretary of State for the Environment, as respects articles 1 to 4 hereof, in exercise of his powers under sections 53(9) and 68(8) of the Local Government, Planning and Land Act 1980 (a) and the Secretary of State for the Environment and the Minister of Transport, as respects article 5 hereof, in exercise of their powers under section 85(1) of that Act and of all other powers enabling them in that behalf, hereby make the following order:—

- 1. This order may be cited as the Local Government, Planning and Land Act 1980 (Commencement No. 2) Order 1980.
- 2. In this order "the Act" means the Local Government, Planning and Land Act 1980.
- 3. The year beginning with 1st April 1981 is hereby appointed as the commencing year for the purposes of Part VI of the Act.
- 4. The amendments made by subsections (2) to (6) of section 68 of the Act shall come into force on 11th December 1980.
 - 5.—(1) The following provisions of the Act, namely:—
 - (a) section 72(1) and (2);
 - (b) section 73; and
 - (c) section 74,

shall, for the purpose of enabling the Secretary of State and the Minister of Transport to make or withdraw specifications of amounts of prescribed expenditure or to give directions for the year commencing 1st April 1981 and subsequent years, come into force on 11th December 1980.

- (2) The following provisions of the Act, namely:—
 - (a) section 71:
 - (b) section 75(5);
 - (c) section 76;
 - (d) section 84; and
 - (e) Schedule 12,

shall come into force on 11th December 1980.

(3) The provisions of Part VIII of the Act not specified in sub-paragraphs (1) and (2) above shall come into force on 1st April 1981.


