# The Apple and Pear Development Council (Amendment) Order 1980

Laid before Parliament in draft

Made - - - 17th December 1980

Coming into Operation 18th December 1980

The Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred on him by section 8(1) and (2) of the Industrial Organisation and Development Act 1947(a), and of all other powers enabling him in that behalf, after consultation with the Apple and Pear Development Council (established under the said Act and continued in being by the Apple and Pear Development Council Order 1980(b)), with the organisations appearing to him to be representative of substantial numbers of persons carrying on business in the industry and with the organisations representative of persons employed in the industry appearing to the Minister to be appropriate, hereby makes the following Order a draft whereof has been laid before Parliament and approved by a resolution of each House of Parliament:—

#### Citation and commencement

1. This Order may be cited as the Apple and Pear Development Council (Amendment) Order 1980 and shall come into operation on the day immediately following the day on which it is made.

Amendment of the Apple and Pear Development Council Order 1980

- 2. The Apple and Pear Development Council Order 1980 shall be amended—
  - (a) by substituting in article 9(1) thereof for the words "an annual charge at a rate not exceeding twenty nine pounds" the words "an annual charge at a rate not exceeding forty pounds";
  - (b) by inserting after article 9(3) thereof the following paragraph:—
    - "(3A) In addition to any charge imposed under paragraph (1) of this article the Council may, with the approval of the Minister, for the purposes of enabling them to meet their administrative and other expenses incurred or to be incurred in connection with any scheme for promoting the production and marketing of standard products, impose on every person participating in any such scheme, being a person carrying on any business consisting wholly or partly in the production of, or dealing in, any of the materials of the industry, a charge at a rate not exceeding twelve new pence for every ten kilograms by net weight of such standard products marketed by him.";

- (c) by deleting from article 9(4) thereof the words "for any year";
- (d) by inserting after paragraph 3 of Schedule 1 thereto the following paragraph:—

"3A. Advising persons who participate in any scheme for promoting the production and marketing of standard products as to the prices at which they should endeavour to sell such products, and undertaking inquiry for the purpose of enabling the Council so to advise.".

### EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which comes into operation on 18th December 1980, amends the Apple and Pear Development Council Order 1980.

The Order-

- (a) raises the maximum rate of annual charge which the Council may impose on growers from £29.00 to £40.00 per hectare;
- (b) makes provision for the imposition of an additional charge for enabling the Council to meet their expenses in connection with any scheme to promote the production and marketing of standard products; and
- (c) assigns to the Council an additional function (article 2(d)).
