1980 No. 694 (L. 7)**COUNTY COURTS****The County Court Districts (Frome) Order 1980**

Made - - - 15th May 1980

Coming into Operation 14th June 1980

The Lord Chancellor in exercise of the powers conferred on him by section 2 of the County Courts Act 1959(a), hereby makes the following Order:—

1.—(1) This Order may be cited as the County Court Districts (Frome) Order 1980 and shall come into operation on 14th June 1980.

(2) In this Order the “principal Order” means the County Court Districts Order 1970(b) as amended(c).

2.—(1) The holding of the Frome County Court shall be discontinued and the entries relating to this court in Schedule 1 to the principal Order shall be deleted.

(2) The amendments set out in Schedule 1 to this Order shall be made in Schedule 1 to the principal Order in their proper alphabetical position.

3. The amendments set out in Schedule 2 to this Order shall be made in Schedule 2 to the principal Order.

4. No process shall be invalid only because the court is described therein by the name by which it was known prior to the coming into operation of this Order.
