# The County Courts Jurisdiction Order 1981

Laid before Parliament in draft

Made - - - - 31st July 1981

Coming into Operation 1st October 1981

At the Court at Buckingham Palace, the 31st day of July 1981

Present,

The Queen's Most Excellent Majesty in Council

Whereas a draft of the following Order was laid before Parliament and approved by resolution of each House of Parliament:

Now, therefore, Her Majesty, in exercise of the powers conferred by section 192 of the County Courts Act 1959(1) and all other powers enabling Her Majesty, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

- 1. This Order may be cited as the County Courts Jurisdiction Order 1981 and shall come into operation on 1st October 1981.
- 2. Subject to the transitional provisions set out in the Schedule to this Order, the enactments specified in column 1 of the following table shall be amended by substituting for the sum specified in column 2 opposite each such enactment, wherever such sum appears therein, the sum so specified in column 3:—

#### **SCHEDULE**

### TRANSITIONAL PROVISIONS

- 1. The amendments made by this Order in sections 45, 68 and 146 of the County Courts Act 1959 (hereinafter referred to as "the Act") shall apply to proceedings begun before, as well as to proceedings begun on or after, 1st October 1981.
  - 2. In relation to proceedings begun before 1st October 1981—
    - (a) the amendments made by this Order in section 47 of the Act shall not apply;
    - (b) the High Court, or a judge thereof, shall have the same powers under section 54 of the Act as it or he would have if the proceedings had been begun after that date; and
    - (c) a judge may, if he sees fit, refuse to make an order under section 66 of the Act if the proceedings are within the jurisdiction of a county court as extended by this Order.

#### **EXPLANATORY NOTE**

This Order raises from £2,000 to £5,000 the jurisdiction of the county courts in actions founded on contract or tort, in actions for money recoverable by statute and in proceedings relating to solicitors' costs under section 69(3) of the Solicitors Act 1974. It raises from £2,000 to £5,000 the jurisdiction of those courts in respect of extortionate credit agreements under section 139 of the Consumer Credit Act 1974. It also raises from £15,000 to £30,000 the equity jurisdiction of the county courts; it increases from £1,200 to £3,000 the amount which a plaintiff proceeding in the High Court must recover in order to be entitled to costs on the High Court scale, and from £350 to £600 the amount which such a plaintiff must recover in order to be entitled to any costs. The Order also enables the trial jurisdiction of county court registrars to be raised from £200 to £500.
