**OFFSHORE INSTALLATIONS**

**The Continental Shelf (Protection of Installations)  
(No.14) Order 1981**

*Made - - - - - 3rd September 1981*

*Laid before Parliament 7th September 1981*

*Coming into Operation 8th September 1981*

The Secretary of State, in exercise of powers conferred by section 2(1) and (3) of the Continental Shelf Act 1964<sup>(a)</sup> (hereinafter referred to as "the Act") and now vested in him <sup>(b)</sup>, hereby orders as follows:—

1. This Order may be cited as the Continental Shelf (Protection of Installations) (No.14) Order 1981 and shall come into operation on 8th September 1981.

2.—(1) Subject to paragraph (2) of this Article, for the purpose of protecting the offshore installation described in the Schedule hereto, ships are hereby prohibited from entering, without the consent of the Secretary of State, that area (hereinafter referred to as a "safety zone") specified in the said Schedule (being a part of an area designated by an Order in Council made under section 1(7) of the Act).

(2) Nothing in paragraph (1) of this Article shall apply to prohibit a ship from entering a safety zone:

- (a) in connection with the laying, inspection, testing, repair, alteration, renewal or removal of any submarine cable or pipe-line in or near that safety zone;
- (b) to provide services for, to transport persons or goods to or from, or under the authority of a government department to inspect, an offshore installation in that safety zone;
- (c) if it is a ship belonging to a general lighthouse authority and it enters to perform duties relating to the safety of navigation;
- (d) when carrying out movements with a view to saving or attempting to save life or property;
- (e) owing to stress of weather; or
- (f) when in distress.

3. In the table in the Schedule to the Continental Shelf (Protection of Installations) (No.9) Order 1981<sup>(c)</sup> (safety zone for Ninian well 3/3-5a), for the co-ordinate in column 2 (longitude east) there shall be substituted the following co-ordinate, namely "01° 24' 46.00"".

## SCHEDULE

## AREA SPECIFIED AS A SAFETY ZONE

The area within a radius of 500 metres of the point having the co-ordinates of latitude and longitude according to European Datum (1950) set out in columns 1 and 2 of the table below in respect of the offshore installation the name or other designation of which is set opposite those co-ordinates in column 3 of the said table.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order specifies as a safety zone a sea area (being an area within a radius of 500 metres of a certain offshore installation) and prohibits ships from entering the zone except with the permission of the Secretary of State or in the circumstances provided for in Article 2(2). The Order also corrects an error in the Continental Shelf (Protection of Installations) (No.9) Order 1981.
