The Education (Scotland) Act 1981 (Commencement No. 1) Order 1981

Made -

30th October 1981

In exercise of the powers conferred on me by section 22(2) of the Education (Scotland) Act 1981(a) I hereby make the following order:—

1. This Order may be cited as the Education (Scotland) Act 1981 (Commencement No. 1) Order 1981.

Interpretation

2. In this order, "the Act" means the Education (Scotland) Act 1981.

Coming into force of certain provisions of the Act

3. The provisions of the Act specified in column 1 of each of the Schedules 1 to 6 to this order (which relate to the matters specified in column 2 thereof) shall come into force on the day specified in the heading to that Schedule.

Transitional provisions

- 4.—(1) The coming into force of the following provisions of the Act namely section 15 in so far as it gives effect to the provisions of Schedule 6 specified in paragraph (2) below, section 21(3) in so far as it gives effect to the provisions of Schedule 9 repealing provisions of the principal Act specified in paragraph (3) below and Schedules 6 and 9 as respects those respective provisions shall not affect
 - (a) the exercise of any power or performance of any duty under Part VI of the principal Act as originally enacted in relation to the making, framing or approval of a scheme for the reorganisation of any endowment under that Part VI or a scheme for amending any such scheme or any scheme made or approved under the Educational Endowments (Scotland) Acts 1928 to 1935(b), Part VI of the Education (Scotland) Act 1946(c) or Part VI of the Education (Scotland) Act 1962(d) in respect of which the Secretary of State or as the case may be the Scottish Universities Committee of the Privy Council have prepared a draft scheme in accordance with section 112 of the principal Act; or
 - (b) the coming into operation of any such scheme under Part VI of the principal Act as originally enacted.
- (2) The provisions of Schedule 6 to the Act specified for the purposes of paragraph 1 above are as follows namely-Paragraphs 4(a), (b), (c) and (h); 5; 6; 8; 9; 11; 12; 13; 14; 15; 16 and 19.

EXPLANATORY NOTE

(This Note is not part of the Order)

This Order brings certain provisions of the Education (Scotland) Act 1981 into force subject in the case of section 15, Schedule 6, section 21(3) and Schedule 9 to the transitional provisions contained in Article 4 of the Order. Those transitional provisions disapply the sections and Schedules of the Act as mentioned in Article 4 to those educational endowments which are in process of being reorganised or amended by the Secretary of State or the Scottish Universities Committee of the Privy Council, in respect of that reorganisation or amendment.

The provisions specified in Schedule 1 to the Order are brought into force on 30th October 1981; those specified in Schedule 2 on 10th November 1981, those specified in Schedule 3 on 1st December 1981, those specified in Schedule 4 on 1st January 1982, those specified in Schedule 5 on 15th February 1982 and those specified in Schedule 6 on 15th March 1982.
