MEDICINES

The Medicines (Pharmacies) (Applications for Registration and Fees) Amendment Regulations 1981

Made - - - - 27th November 1981

Laid before Parliament 8th December 1981

Coming into Operation 1st January 1982

The Secretaries of State respectively concerned with health in England, in Wales and in Scotland and the Department of Health and Social Services for Northern Ireland, acting jointly, in exercise of powers conferred by sections 75(1) and 76(1), (2) and (6) of the Medicines Act 1968(a) and now vested in them (b) and of all other powers enabling them in that behalf, after consulting such organisations as appear to them to be representative of interests likely to be substantially affected by these regulations, hereby make the following regulations:—

Citation and commencement

1. These regulations may be cited as the Medicines (Pharmacies) (Applications for Registration and Fees) Amendment Regulations 1981 and shall come into operation on 1st January 1982.

Amendment of regulations

2. Regulation 3 of the Medicines (Pharmacies) (Applications for Registration and Fees) Regulations 1973(c) is amended as follows:

- (a) in paragraph (1) (fee for registration of premises), for “£60” there is substituted “£64” and for “£21” (fee where premises are in Northern Ireland) there is substituted “£30”;
- (b) in paragraph (2) (retention fee), for “£35” there is substituted “£37.50” and for “£21” (fee where premises are in Northern Ireland) there is substituted “£27”; and
- (c) in paragraph (3) (additional sum by way of penalty), for “£25” there is substituted “£27” and for “£17.50” (sum where premises are in Northern Ireland) there is substituted “£20”.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These regulations amend the Medicines (Pharmacies) (Applications for Registration and Fees) Regulations 1973. They increase the fees for registration of premises at which a retail pharmacy business is or is to be carried on, the subsequent annual fees (retention fees) and the penalty (payable in circumstances specified in section 76(2) of the Medicines Act 1968) for failure to pay retention fees.
