The County of Devon (Electoral Arrangements) Order 1981

Made - - - 3rd December 1981

Coming into operation in accordance with Article 2

Whereas in pursuance of section 51(1) of the Local Government Act 1972(a) the Local Government Boundary Commission for England on 16th December 1980 submitted proposals for the future electoral arrangements for the County of Devon:

And whereas in giving effect to those proposals I have decided to make certain modifications:

Now, therefore, in exercise of the power conferred upon me by sections 51(2) and 67 of the said Act, I hereby make the following Order:—

- 1. This Order may be cited as the County of Devon (Electoral Arrangements) Order 1981.
- 2. This Order shall come into operation on 2nd May 1985 except that for the purpose of all proceedings preliminary or relating to an election to be held on or after that day the said Order shall come into operation on 10th October 1984.
- 3.—(1) The existing electoral divisions of the County of Devon shall be abolished and the said county shall be divided into eighty-five electoral divisions which shall bear the names set out in column 1 of the Schedule to this Order, and each such electoral division, except those referred to in paragraph (2) below, shall comprise the existing areas specified opposite thereto in column 2 of the said Schedule.
- (2) Each electoral division named in column 1 of the Schedule to this Order which is in the City of Exeter, the District of North Devon or the Borough of Torbay shall comprise the area of the district wards specified opposite thereto in column 2 of the said Schedule and the areas of those district wards are:
 - (i) in the city of Exeter, the areas demarcated by blue lines on the map referred to in the City of Exeter (Electoral Arrangements) Order 1979(b) and designated on that map by reference to the names of the wards of that City as set out in column 1 of Schedule 1 to that Order;
 - (ii) in the District of North Devon, the existing areas specified in column 2 of the Schedule to the District of North Devon (Electoral

- Arrangements) Order 1980(a) opposite to the names of the wards of that District as set out in column 1 of that Schedule; and
- (iii) in the Borough of Torbay, the areas demarcated by blue lines on the map referred to in the Borough of Torbay (Electoral Arrangements) Order 1979(b) and designated on that map by reference to the names of the wards of that Borough as set out in column 1 of the Schedule to that Order.
- (3) The number of councillors to be elected for each electoral division constituted by this Order shall be one.
- 4. Where a boundary is described in the Schedule to this Order as running along a road, railway line, footway, waterway or other similar geographical feature, it shall be treated as running along the centre line thereof.
- 5. The ordinary elections of all councillors for the County of Devon shall be held simultaneously on the ordinary day of election of county councillors in 1985 and every fourth year thereafter.
