FRIENDLY SOCIETIES

The Friendly Societies (Fees) Regulations 1981

<i>Made - - - -</i>	11th December 1981
<i>Laid before Parliament</i>	23rd December 1981
<i>Coming into Operation</i>	11th January 1982

The Treasury, in exercise of the powers conferred on them by section 104(1) of the Friendly Societies Act 1974(a) and by article 2 of the Friendly Societies (Fees) Order 1971(b) and of all other powers enabling them in that behalf, hereby make the following Regulations:—

1. These Regulations may be cited as the Friendly Societies (Fees) Regulations 1981 and shall come into operation on 11th January 1982.
2. The Friendly Societies Regulations 1975(c) shall be amended by substituting for Schedule 2 thereto the following Schedule:—

1. For the acknowledgement of registration of a society (except as hereinafter provided).....	163.00

4. The fees specified in this paragraph shall be payable where the society or branch concerned has by notice elected as aforesaid:

7. For registration of an instrument of dissolution or alteration therein where a society or branch has—	
(a) 100 members or less.....	33.00
(b) more than 100 members but not more than 500.....	49.00
(c) more than 500 members but not more than 1,000.....	65.00
(d) more than 1,000 members.....	81.00
8. For a reference of a dispute to the Registrar.....	4.00
9. For the determination of a Registrar on a dispute or for the award of a registrar for dissolution where the matter is settled without a hearing or upon one hearing without an adjournment.....	21.00
10. Where on a dispute or on an application for an award of dissolution more than one hearing is required or where the hearing is adjourned—	
the same fee as where the matter is settled upon one hearing without adjournment and in addition for every hearing after the first and for every adjournment.....	21.00
11. For the award or direction of a Registrar for the appropriation or division of assets of a society or branch, an additional fee as follows:—	
where the value of the assets is less than £300, 29 per cent of that value;	
where the value of the assets is £300 or more, £88 with an additional £5.50 for every £100 or part thereof in excess of £300.	
12. Where an application is made for an investigation into the affairs of a society or branch with a view to an award of dissolution thereof, the Chief Registrar may, if he thinks fit, at any time before making his award require the payment of such further fee as he may deem reasonable not exceeding—	
where the number of members does not exceed 150.....	239.00
where the number of members exceeds 150 but does not exceed 250.....	319.00
where the number of members exceeds 250 but does not exceed 350.....	399.00
where the number of members exceeds 350 but does not exceed 500.....	479.00

13. For every inspection on the same day of documents in the custody of the Registrar relating to one and the same society or branch..... 2.00
 14. For every document (except as otherwise provided) required to be signed by a Registrar, or to bear the seal of the Central Office, not chargeable with any other fee to the Registrar..... 8.00
provided that such fee shall not be paid by a society or branch which has not by notice elected as in paragraph 4 of this Schedule.
 15. For a copy or extract of any document in the custody of the Registrar, not exceeding 216 words, £4 and if exceeding that number, 88p per folio of 72 words, in addition to the fee for the signature of a Registrar, or for the seal of the Central Office; provided that where a photocopy is supplied the fee charged therefore may be of an amount less than the fee payable on the basis of word content.
 16. For any document certified as a true copy of a document in the custody of the Registrar, where the copy so certified is not made by the Registrar, £1.75 for the examination of such copy, and if the copy exceeds 216 words, for every additional folio of 72 words, 35p (in addition to the fee for the signature of a Registrar, or seal of the Central Office).
 17. The fee for the acknowledgement of registration of a society registered as a working men's club the rules of which are in the form of model rules, where the application for the registration is made through and endorsed by the association or body which has sponsored the rules contained in the said model, shall be £113.
 18. The fee for the acknowledgement of registration of an amendment of rules of a society registered as a working men's club, being a substitution of an entire set of rules for the existing set of rules, where the entire set of rules are in the form of model rules and where the application for registration is made through and endorsed by the association or body which has sponsored the rules contained in the said model, shall be £80.
 19. The Chief Registrar may at his discretion reduce or waive the fee for an award on a dispute.
 20. No fee shall be payable in respect of the examination or authentication of copies of rules or amendments of rules to be used for recording under section 10 of the Friendly Societies Act 1974".
3. The Friendly Societies (Fees) Regulations 1980(a) are hereby revoked.
