# HIGH COURT OF JUSTICIARY, SCOTLAND

# Act of Adjournal (Fees in the High Court of Justiciary) (Amendment) 1981

Made - - - - 25th March 1981 Coming into Operation 27th April 1981

The Lord Justice-General, the Lord Justice-Clerk and the Lords Commissioners of Justiciary, under and by virtue of the powers conferred upon them by section 2 of the Courts of Law Fees (Scotland) Act 1895(a) and of all other powers competent to them in that behalf, do hereby, with the approval of the Treasury, enact and declare:—

#### Citation and commencement

1. This Act of Adjournal may be cited as the Act of Adjournal (Fees in the High Court of Justiciary) (Amendment) 1981 and shall come into operation on 27th April 1981.

#### Amendment of High Court Fees

2. In the Act of Adjournal (Fees in the High Court of Justiciary) 1970(b), for the table of fees in the Schedule there is substituted the table of fees set out in the Schedule to this Act of Adjournal, and the fees so substituted shall be payable in respect of the matters to which they relate from the date this Act of Adjournal comes into operation.

#### Revocation

3. The Act of Adjournal (Fees in the High Court of Justiciary) (Amendment) 1977(c) is revoked.

And the Lords appoint this Act of Adjournal to be recorded in the Books of Adjournal.
