SEEDS

The Seed Potatoes (Fees) (Scotland) Regulations 1981

<i>Made - - - -</i>	31st March 1981
<i>Laid before Parliament</i>	13th April 1981
<i>Coming into Operation</i>	4th May 1981

In exercise of the powers conferred on me by section 16(1), (1A)(e) and (5)(a) of the Plant Varieties and Seeds Act 1964 (a), and of all other powers enabling me in that behalf, after consultation with representatives of such interests as appear to me to be concerned, I hereby make the following regulations:—

Citation and commencement

1. These regulations may be cited as the Seed Potatoes (Fees) (Scotland) Regulations 1981 and shall come into operation on 4th May 1981.

Revocation of previous regulations

2. The Seed Potatoes (Fees) (Scotland) Regulations 1980 (b) are hereby revoked.

Fees

3. There shall be paid in advance in respect of matters arising under the Seed Potatoes Regulations 1978 (c) referred to in the Schedule hereto or under any regulations amending or superseding them the fees respectively specified in the second column of the said Schedule opposite the references to such matters.

4. The said fees shall be payable to the Secretary of State.

5. The Secretary of State may exempt any person or class of person or persons generally from compliance in whole or in part with the provisions of these regulations in relation to payment of fees and any exemptions so made may be made subject to conditions.

SCHEDULE

Matter	Fee
1. Fee for crop inspection in respect of crops entered to produce:	
(a) VTSC grade per half-hectare or part thereof:	£13
Minimum Fee	£26
(b) FS grade per half-hectare or part thereof	£12
(c) AA1 grade per half-hectare or part thereof	£11
Provided that if an application for entry of crops is withdrawn before the arrival of an inspector for the purpose of inspecting the crop for the first time the fee paid will be refunded to the applicant subject to payment of a reduced fee of £1 per half-hectare to cover administrative costs.	
2. Fee for provision of seals and labels including tuber inspections. All grades per tonne or part thereof:	
(a) Labels without tie-holes	80p
(b) Labels with tie-holes and seals	£1
Provided that if labels are returned unused the fee paid may be refunded subject to payment of a reduced fee of 40p per tonne to cover administrative costs.	

EXPLANATORY NOTE

(This Note is not part of the Regulations)

These regulations, which revoke and supersede the Seed Potatoes (Fees) (Scotland) Regulations 1980, are made under the Plant Varieties and Seeds Act 1964 as amended by the European Communities Act 1972.

They prescribe fees in respect of matters arising under the Seed Potatoes Regulations 1978.
