## ANGUILLA

**The Anguilla (Consequential Provisions) Order 1981***Made* - - - 13th April 1981*Coming into Operation* 13th April 1981*Laid before Parliament* 30th April 1981

At the Court at Windsor Castle, the 13th day of April 1981

Present,

The Queen's Most Excellent Majesty in Council

Whereas Anguilla ceased to form part of the territory of the associated state of St. Christopher, Nevis and Anguilla on 19th December 1980, when section 1(1) of the Anguilla Act 1980(a) came into force:

Now, therefore, Her Majesty, by virtue of the powers conferred upon Her by sections 13(2) and 15 of the West Indies Act 1967(b) and section 1(1) of the Anguilla Act 1980 (which Act extended to the Associated State of St. Christopher, Nevis and Anguilla notwithstanding anything in the said Act of 1967 or any Order in Council made under it) is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

Citation and commencement.

1. This Order may be cited as the Anguilla (Consequential Provisions) Order 1981 and shall come into operation on 13th April 1981.

Change of style.

2.—(1) The associated state hitherto styled St. Christopher, Nevis and Anguilla shall henceforth be styled St. Christopher and Nevis.

(2) In relation to any period commencing on or after 19th December 1980—

- (a) any reference in any relevant law to St. Christopher, Nevis and Anguilla shall, unless the context otherwise requires, have effect as a reference to St. Christopher and Nevis;
- (b) any such reference in any such law shall, to the extent that the law has effect in or in relation to Anguilla and unless the context otherwise requires, also have effect as if it were a reference to Anguilla,

And accordingly where the words “ St. Christopher, Nevis and Anguilla ” occur in any such law that law shall, unless the context otherwise requires, have effect as if the words “ St. Christopher and Nevis ” or, as the case may be, the word “ Anguilla ” had been substituted therefor.

(3) In this section "relevant law" means any enactment of the Parliament of the United Kingdom (including the West Indies Act 1967) or any Order in Council or other instrument having effect by virtue of such an enactment, being an enactment, Order or other instrument made before the commencement of this Order.

(4) This section shall be deemed to have come into operation on 19th December 1980.

#### EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order provides that the associated state hitherto known as St. Christopher, Nevis and Anguilla (from which Anguilla was separated on 19th December 1980) shall henceforth be known as St. Christopher and Nevis. It also makes provision for the interpretation of references to St. Christopher, Nevis and Anguilla in Acts of Parliament and instruments made thereunder. These provisions are deemed to have had effect from 19th December 1980.
