HIGH COURT OF JUSTICIARY, SCOTLAND

Act of Adjournal (Circuits)(Amendments) 1981

Made - - - - 1st July 1981 Coming into Operation 22nd July 1981

The Lord Justice General, the Lord Justice Clerk and Lords Commissioners of Justiciary, by virtue of the powers conferred upon them by Section 114 of the Criminal Procedure (Scotland) Act 1975(a), and of all other powers competent to them in that behalf, and after consultation with the Lord Advocate, do hereby enact and declare—

Citation and commencement

1. This Act of Adjournal may be cited as the Act of Adjournal (Circuits)(Amendments) 1981 and shall come into operation on 22nd July 1981.

Amendments

- 2. In the Act of Adjournal (Circuits) 1980(b)—
 - (a) in paragraph 2—
 - (i) after sub-paragraph (1) there shall be inserted a new sub-paragraph in the following terms—
 - "(1A) The circuit specified in Schedule 3 to this Act of Adjournal shall be held during 1981 at the place, on the dates and at the times specified therein.";
 - (ii) in sub-paragraph (2) for the word "thereof" there shall be substituted the words "under this paragraph";
 - (b) in paragraph 3, there shall be added the following sub-paragraph—
 "(3) In relation to a circuit specified in Schedule 3, the Clerk of
 Justiciary may require the Sheriff of South Strathclyde, Dumfries
 and Galloway on the issue of a requisition notice by the Clerk of
 Justiciary to return to him a list of persons qualified and liable to
 serve as jurors from the General Jury Book for the Sheriff Court
 District of Airdrie in such numbers as may be required for each of
 the circuits";
 - (c) after Schedule 2 there shall be added the following Schedule—
