Parochial Fees (No. 1) Order 1981

Made (Approved by the General Synod) 6th July 1981

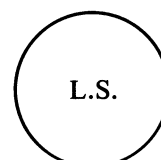
Laid before Parliament 10th July 1981

Coming into Operation 1st January 1982

We, the Church Commissioners for England, in exercise of the powers conferred on us by section 2(1) of the Ecclesiastical Fees Measure 1962^(a) and all other powers enabling us in that behalf, do hereby order as follows:—

1. The Parochial Fees Order 1980^(b) is hereby altered in the manner indicated in paragraph 2 hereof.
2. The Schedule hereto is substituted for the Schedule to the Parochial Fees Order 1980.
3. This Order may be cited as the Parochial Fees (No. 1) Order 1981, and shall come into operation on the 1st January 1982.
