## ROAD TRAFFIC

**The Removal and Disposal of Vehicles (Loading Areas)  
(Amendment) Regulations 1981**
*Made - - - - 6th July 1981**Laid before Parliament 27th July 1981**Coming into Operation 17th August 1981*

The Secretary of State for Transport, as respects England, and The Secretary of State for Wales, as respects Wales, in exercise of the powers conferred by sections 20, 52 and 53 of the Road Traffic Regulation Act 1967(a) and now vested in them(b), and of all other enabling powers, and after consultation with representative organisations in accordance with section 107(2) of the Road Traffic Regulation Act 1967, hereby make the following Regulations:—

1. These Regulations may be cited as the Removal and Disposal of Vehicles (Loading Areas) (Amendment) Regulations 1981, and shall come into operation on 17th August 1981.

2. The Removal and Disposal of Vehicles (Loading Areas) Regulations 1978(c) shall be amended so that in the Regulations specified in column 1 of the Table below for the words specified in column 2 of that Table there are substituted the words specified in column 3 of that Table.

## EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

The Regulations amend the Removal and Disposal of Vehicles (Loading Areas) Regulations 1978 by increasing from £22 to £36 the charge for removing a vehicle from a loading area in the City of London or the Metropolitan Police District and from £20 to £30 from a loading area elsewhere in England or anywhere in Wales, from £2 to £3 the charge for storing a vehicle for each period of 24 hours or part thereof, and from £6 to £10 the charge for disposing of a vehicle.
