- 1. This order may be cited as the Local Government and Planning (Scotland) Act 1982 (Commencement No. 1) Order 1982.
- 2. The provisions of the Local Government and Planning (Scotland) Act 1982 (hereinafter referred to as "the Act") which are specified in Column 1 of the Schedule to this order and which relate to the subject matter specified in Column 2 thereof shall come into operation on 1st September 1982.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order brings into operation on 1st September 1982 the provisions of the Local Government and Planning (Scotland) Act 1982 relating to rating and valuation (Part I), the power of a local authority to enter into arrangements with the Manpower Services Commission (section 8), the transfer of officers and property of local authorities consequential on the provisions of Part II of the Act (sections 33, 34, 35), the power of a local authority to make an advance for the acquisition of land or the erection of buildings (section 49), the power of a local authority to incur expenditure under section 83 of the Local Government (Scotland) Act 1973 for certain purposes not otherwise authorised (section 50), improvement grants for the disabled (section 51), amendments to the Tenants' Rights, Etc. (Scotland) Act 1980 (sections 53, 54, 55), the maintenance of sewage treatment works and waterworks (section 56), the abolition of a number of public bodies whose functions have been superseded (sections 61, 62, 63) and certain supplementary matters, minor and consequential amendments and repeals (sections 64 to 68).
