Order 1982***Made* - - - - - 27th September 1982*Laid before Parliament* 28th September 1982*Coming into Operation* 29th September 1982

The Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with the sea fishing industry in Scotland and Wales, acting jointly, in exercise of the powers conferred on them by sections 1 and 20(1) of the Sea Fish (Conservation) Act 1967(a), and the said Minister, the said Secretaries of State and the Secretary of State concerned with the sea fishing industry in Northern Ireland, acting jointly, in exercise of the powers conferred on them by sections 15(3) and 20(1) of the said Act(b), and of all other powers enabling them in that behalf, hereby make the following order:—

Title and commencement

1. This order may be cited as the Immature Sea Fish (Variation) (No. 3) Order 1982 and shall come into operation on 29th September 1982.

Variation of the Immature Sea Fish Order 1981

2. The Immature Sea Fish Order 1981(a) shall be further varied by substituting the date "31st December 1982" for the date mentioned in article 7 thereof (which specifies the date on which the order shall cease to have effect).
