The Derelict Land Clearance Areas Order 1982

Made -8th July 1982 Laid before Parliament 9th July 1982 Coming into Operation 1st August 1982

The Secretary of State, in exercise of the powers conferred by section 8(6) and (7) of the Local Employment Act 1972(a) and now vested in him(b), hereby makes the following Order:-

- 1. This Order may be cited as the Derelict Land Clearance Areas Order 1982 and shall come into operation on 1st August 1982.
- 2. The employment office areas described in the Schedule to this Order are hereby specified as derelict land clearance areas for the purposes of the Local Employment Act 1972.
