TELEGRAPHS

The Wireless Telegraphy (General Licence Charges) (Amendment) Regulations 1983

Made - - - 29th April 1983

Laid before Parliament 10th May 1983

Coming into Operation 1st June 1983

The Secretary of State, in exercise of the powers conferred by section 2(1) of the Wireless Telegraphy Act 1949(a) as enacted, and as extended by the Wireless Telegraphy (Channel Islands) Order 1952(b) and the Wireless Telegraphy (Isle of Man) Order 1952(c), and now vested in him (d), hereby, with the consent of the Treasury, makes the following Regulations:—

- 1. These Regulations may be cited as the Wireless Telegraphy (General Licence Charges) (Amendment) Regulations 1983 and shall come into operation on 1st June 1983.
- 2. In these Regulations "the principal Regulations" means the Wireless Telegraphy (General Licence Charges) Regulations 1968(e).
- 3. Part I of the Schedule to the principal Regulations shall be amended as follows:—
 - (a) for "£8.00" in all places where it occurs in the entries numbered 1A and 2A (Amateur Licences) there shall be substituted "£12.00";
 - (b) for the entry numbered 5 (Demonstration Licence) there shall be substituted the entry set out in Schedule 1 to these Regulations;
 - (c) for the entry numbered 9 (Private Mobile Radio Licence) there shall be substituted the entry set out in Schedule 2 to these Regulations;
 - (d) for "£6.00" in all places where it occurs in the entries numbered 11,12 and 17 (Radar (Land) Station Licence; Radio Beacon Licence; Testing and Development (Suppressed Radiation) Licence) there shall be substituted "£7.00";

- (e) for "£18.60" in both places where it occurs in the entry numbered 14 (Radio Paging Licence) there shall be substituted "£20.00";
- (f) for "£12.50" in all places where it occurs in the entries numbered 15, 16 and 18 (Ship (Receiving Only) Licence; Testing and Development (Radiating) Licence; Training Establishment Licence) there shall be substituted "£14.00".
- 4. Part II of the Schedule to the principal Regulations shall be amended as follows:—
 - (a) for "£8.00" in both places where it occurs in the entry numbered 1 (Aircraft Licence) there shall be substituted "£15.00";
 - (b) for "£17.50" in both places where it occurs in the entry numbered 2 (Ship Licence) there shall be substituted "£25.00";
 - (c) after the entry numbered 2 there shall be added the entry set out in Schedule 3 to these Regulations.
- 5. Regulation 5(1) of the principal Regulations is hereby revoked.

Ship Licence (VHF)	A licence to establish and use a sending and receiving station for wireless telegraphy in a ship for the purpose of (a) sending on specified VHF frequencies only messages to coast stations, ship stations and aircraft stations and (b) receiving messages sent from coast stations, ship stations, aircraft stations, special service stations and radionavigation stations for general reception by ship stations or for reception by the said station, and messages sent by authorised broadcasting stations—whether or not the licence in addition authorises the establishment and use of stations for wireless telegraphy in lifeboats or other survival-craft associated with or normally carried by the ship, or of a radar station for wireless telegraphy in the ship.	£15·00	£15.00

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations alter the fees payable on the issue and renewal of certain wireless telegraphy licences. Apart from the Ship (Receiving Only) Licence all the licences concerned authorise the sending and receiving of messages.

Schedule 1 to the Regulations provides that in place of the fee of £18-60 for each station licensed by a Demonstration Licence there shall be fees calculated according to a scale based on multiples of stations. Schedule 2 revises the fees for Private Mobile Radio Licences, which are already based on a similar scale.

Schedule 3 sets at £15 the fee payable on the issue and renewal of a Ship Licence which authorises transmission on VHF frequencies only.
