# The Anglian Water Authority (Variation of the Longstanton and Swavesey Awards) Order 1984

Made - - - -

12th October 1984

Coming into Operation

10th December 1984

Whereas the Anglian Water Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 25(1) of the Land Drainage Act 1976(a);

And whereas the Minister has decided to confirm the Scheme, a copy of which is annexed hereto;

Now, therefore, the Minister, in exercise of the powers conferred upon him by sections 25(4) and 109(6) of the Land Drainage Act 1976, and of all other powers enabling him in that behalf, hereby makes the following Order:—

- 1. This Order may be cited as the Anglian Water Authority (Variation of the Longstanton and Swavesey Awards) Order 1984 and shall, unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.
  - 2. The Scheme is hereby confirmed.
- 3. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Anglian Water Authority and shall be part of the administrative expenses of that Authority.

#### LAND DRAINAGE ACT 1976

### ANGLIAN WATER AUTHORITY

# SOUTH CAMBRIDGESHIRE DISTRICT COUNCIL

Whereas section 25 of the Land Drainage Act 1976 provides that where any Award made under any public or local act contains any provision which in any manner affects or relates to the drainage of land in a water authority area then the water authority may submit to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a scheme for revoking, varying or amending that provision;

And whereas by Awards dated 10th April 1816 and 18th December 1840 particulars of which are set out in the Schedule hereto (hereinafter called "the Awards") provision was made for the repair and maintenance work as therein specified of certain drains and also in the Award dated 18th December 1840 for the repair and maintenance of certain culverts (in the said Award referred to as tunnels and bridges) including in particular those drains and culverts (hereinafter called "the said drains and culverts") which are shown coloured red and green respectively on the map sealed by the Anglian Water Authority (hereinafter called "the Water Authority") in relation to this Scheme;

And whereas the responsibility for the repair and maintenance of the said drains and culverts under the Awards has devolved upon the South Cambridgeshire District Council (hereinafter called "the District Council");

And whereas the District Council has agreed with the Water Authority acting in their capacity as the Swavesey Internal Drainage Board in consequence of the Anglian Water Authority (Transfer of Powers of the Swavesey Internal Drainage Board) Order 1983(a) (hereinafter called "the Drainage Board") that on payment by the District Council of the sum of Twenty-four Thousand Six Hundred Pounds to the Drainage Board the District Council shall be relieved of the responsibility for the repair and maintenance of the said drains and culverts.

Now therefore the Water Authority in pursuance of section 25(1) of the Land Drainage Act 1976 submit the following Scheme to the Minister for confirmation.

## **SCHEME**

On a day to be appointed by the Minister (hereinafter called "the appointed day") the provisions of the Awards shall be altered in the following respect that is to say:

The said drains and culverts shall forever hereafter be cleansed, scoured, repaired and maintained by the Drainage Board subject to the payment to them by the District Council of the sum of Twenty-four Thousand Six Hundred Pounds which sum shall be payable on or before the appointed day and shall be accepted by the Drainage Board as full commutation of all the liabilities of the District Council or any other Authority under the Awards or otherwise in respect of the said drains and culverts: Provided that nothing herein shall operate to release the District Council of any duty imposed by the said Awards in respect of Public Bridges save as herein before provided.
