**REGISTRATION OF BIRTHS, DEATHS,
MARRIAGES, ETC.****The Registration of Births, Deaths and Marriages (Fees)
(Scotland) Amendment Regulations 1985***Made* - - - 21st February 1985*Laid before Parliament* 8th March 1985*Coming into Operation* 1st April 1985

In exercise of the powers conferred upon me by sections 38(2), 43(8), 47 and 54(1)(b) of the Registration of Births, Deaths and Marriages (Scotland) Act 1965(a), and of all other powers enabling me in that behalf, and with the approval of the Secretary of State, I hereby make the following regulations:—

1. These regulations may be cited as the Registration of Births, Deaths and Marriages (Fees) (Scotland) Amendment Regulations 1985 and shall come into operation on 1st April 1985.

2. Schedule 1 to the Registration of Births, Deaths and Marriages (Fees) (Scotland) Regulations 1983(b) shall be amended as follows:—

(a) For the entries in columns 2, 3 and 4 relating to the service of “General search in the parochial registers” there shall be substituted the following(c):—

“General search in the parochial registers —

per day or part thereof	£3.75	£4.00”;

(b) For the entries in columns 2, 3 and 4 relating to the service of “Inclusive general search in the parochial registers and in the indexes to the statutory registers” there shall be substituted the following:—

per week	£22.50	£24.00
per month	£62.50	£66.00
per quarter	£125.00	£132.00”;

(c) The entries in column 3 of Schedule 1 to S.I. 1983/1795 as substituted by this regulation show the amounts which were payable under S.I. 1983/1795 before 1st April 1985.

- (c) For the entries in columns 2, 3 and 4 relating to the service of "Recording of name, or change of name or surname, or alternative name" there shall be substituted the following —

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Registration of Births, Deaths and Marriages (Fees) (Scotland) Regulations 1983 so as to increase certain fees with effect from 1st April 1985. The fee per day or part thereof for a general search in the parochial registers is increased from £3.75 to £4.00. The fee per day or part thereof in respect of an inclusive general search in the parochial registers and in the indexes to the statutory registers provided under the Registration of Births, Deaths and Marriages (Scotland) Act 1965 is increased from £7.50 to £8.00, the fee per week from £22.50 to £24.00, the fee per month from £62.50 to £66.00 and the fee per quarter from £125.00 to £132.00. The fee for recording of name, or change of name or surname, or alternative name is increased from £12.00 to £13.00.
