Citation

1. This order may be cited as the National Heritage (Scotland) Act 1985 Commencement Order 1985.

Interpretation

2. In this order—

"the Act" means the National Heritage (Scotland) Act 1985.

Appointed date

3. The provisions of the Act specified in the first columns of Schedules 1, 2, and 3 to this order (to which the matters specified in the second columns thereof relate) shall come into force respectively on 4th June 1985, 1st October 1985, and 1st April 1986.

- (3) on 1st April 1986, sections 11, 12, 13, 14, 15, 17 (partially), 18(6), 24 and Schedule 2 (partially).
