The Secretary of State for Transport,

- (a) in exercise of the powers conferred by sections 69(4) and 91(1) and (2) of the Transport Act 1968(a), now vested in him(b), and of all other enabling powers; and
- (b) being a Minister designated (c) for the purposes of section 2(2) of the European Communities Act 1972 (d) in relation to the regulation and supervision of qualifications of persons engaged in road transport, in exercise of the powers conferred by that section,

after consultation with representative organisations in accordance with section 91(8) of the Transport Act 1968(e), hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Goods Vehicles (Operators' Licences, Qualifications and Fees) (Amendment) (No. 2) Regulations 1986 and shall come into operation on 12th September 1986.
- 2. The Goods Vehicles (Operators' Licences, Qualifications and Fees) Regulations 1984(f) are hereby further amended in accordance with these Regulations.

- 3. In paragraph (2) of regulation 3—
 - (a) for the definition of "international transport operation" there shall be substituted the following definition—
 - ""international transport operation" has the same meaning as in the 1974 Council Directive, and the expression "national transport operation" shall be construed accordingly; "; and
 - (b) the definition of "national transport operation" shall be omitted.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations further amend the Goods Vehicles (Operators' Licences, Qualifications and Fees) Regulations 1984, by inserting a new definition of the expression "international transport operation" and by, consequentially, deleting the definition of "national transport operation".
