LOCAL GOVERNMENT, SCOTLAND

The Local Government (Inspection of Documents) (Summary of Rights) (Scotland) Order 1986*Made* - - - - 18th August 1986*Coming into Operation* 1st September 1986

The Secretary of State, in exercise of the powers conferred on him by sections 50G(3) and 233 of the Local Government (Scotland) Act 1973(a), and of all other powers enabling him in that behalf, hereby makes the following order:-

Citation and commencement

1. This order may be cited as the Local Government (Inspection of Documents) (Summary of Rights) (Scotland) Order 1986 and shall come into operation on 1st September 1986.

Specification of enactments

2. The enactments listed in the Schedule to this order are specified for the purpose of section 50G(3) of the Local Government (Scotland) Act 1973 (power to specify enactments which confer rights to attend meetings and to inspect, copy and be furnished with documents).
