CONTAMINATION OF FOOD

The Food Protection (Emergency Prohibitions) (Wales)
Amendment No. 2 Order 1986

Whereas the Secretary of State is of the opinion, in accordance with section 1(1)(a) of the Food and Environment Protection Act 1985(a), that there has been or may have been an escape of substances of such descriptions and in such quantities and such circumstances as are likely to create a hazard to human health through human consumption of food;

And whereas the Secretary of State is of the opinion, in accordance with section 1(1)(b) of the said Act, that in consequence of the said escape of substances food which is or may be in the future in the area described in the Schedule to the Food Protection (Emergency Prohibitions) (Wales) Order 1986(b), or which is derived or may be in the future derived from anything in that area, is, or may be, or may become, unsuitable for human consumption;

Now, therefore, the Secretary of State, in exercise of the powers conferred on him by the said section 1(1) and 24(3) of the said Act, and of all other powers enabling him in that behalf, hereby makes the following order:—

Title and commencement

1. This order may be cited as the Food Protection (Emergency Prohibitions) (Wales) Amendment No. 2 Order 1986 and shall come into operation on 29th August 1986.

Partial revocation and amendment

2. The Food Protection (Emergency Prohibitions) (Wales) Order 1986 is revoked to the extent that it imposes prohibitions in respect of sheep which are in the area described in the Schedule to this order on 29th August 1986; and accordingly that order is amended in accordance with the following provisions of this order.

3. After article 6 there shall be inserted the following article —

“Exception

7. Articles 4, 5 and 6 of this order shall not apply in the case of any sheep which was in that part of the designated area described in paragraph 1 of Schedule 2 to this order on 29th August 1986.”

4. After the Schedule there shall be inserted Schedule 2 as set out in the Schedule to this order.

“SCHEDULE 2

Article 7

AREA EXCEPTED FROM ARTICLES 4, 5 AND 6

Area excepted from restrictions on 29th August 1986

1. An area comprising those parts of the designated area which lie within the following boundaries:—

- (1) From the junction of the A548 road within the unmarked road at OS map ref SH 830638 generally eastwards along the A548 road to its junction with the B5384 road and then along the B5384 road to its junction with the unmarked road at Gwytherin at OS map ref SH 877616 and then generally south-westwards along the unmarked road to its crossing with the Afan Derfyn at OS map ref SH 858599 then generally northwards along the course of the Afan Derfyn to its crossing with an unmarked road at OS map ref SH 853624 then generally south-westwards along the unmarked road to its junction at Gors Wen at OS map ref SH 837621 and then generally northwards along the B5113 road to its junction with the A548 road at OS map ref SH 830638.
- (2) From the junction of the A543 road with the unmarked road at OS map ref SH 929568; generally north-eastwards along the A543 road to its junction with the B5401 road at Llyn Bran: southwards along the B5401 road west of Llyn Brenig to its crossing with Afon Alwen at OS map ref SH 963523 then generally north-westwards along the course of the Afon Alwen to the Alwen Reservoir to where it meets with the Afon Alwen and then along the course of the Afon Alwen to its crossing with the A543 road at Cottage Bridge at OS map ref SH 919562 and then generally north-eastwards along the A543 road to its junction with the unmarked road at OS map ref SH 929568.
- (3) From the B4391 road at OS map ref SJ 017306 generally south-eastwards along the B4391 road to its junction with the B4393 road at Abertridwr; south-westwards along the B4393 road to its junction with the unclassified road crossing Afon Efyrynwy, along the unclassified road to the bridge over Afon Efyrynwy and then following the course of Afon Efyrynwy generally south-westwards to the confluence with Afon Conwy, north-eastwards along the course of the Afon Conwy, to the Forestry Commission fence at a point at OS map ref SH 999179 and then generally in a north-eastwards direction following the Forestry Boundary to its junction with the farm fence at OS map ref SH 995188 then generally northwards following the

farm fence to OS map ref SH 998199 and then generally north-westwards along the Forestry fence to where it crosses the stream at OS map ref SH 989204 and then generally following the course of the stream to where it joins Llyn Efyrynwy near the waterfall at OS map ref SH 995206 and then crossing Llyn Efyrynwy in a generally north-westwards direction to the Forestry Boundary at OS map ref SH 988217 and then following the Forestry Boundary to its junction with the stream at OS map ref SH 993225 and then generally eastwards following the course of the stream through the forestry to its junction with the stream at OS map ref SH 999222 and then generally north-eastwards following the course of the stream to where it meets the Forestry Boundary at OS map ref SJ 000224 and then generally north-eastwards following the Forestry Boundary to where it joins the fenced Nant Coedwyr Boundary at OS map ref SJ 003226 and then generally north-eastwards, following the fenced Nant Coedwyr Boundary to where it joins the Severn-Trent Boundary at OS map ref SJ 013240 and then generally north-westwards along the Severn-Trent Boundary passing through OS map references SJ 004244 and SJ 003260 to where it joins the fence at the County Boundary at OS map ref SH 990280 at Cynriau Nod and then generally north-eastwards following the fence along the County Boundary Sheepwalks of Blaencwm and Blaenrhiwarth at OS map ref SJ 003308 and then generally eastwards along the fences on the Northern Side of the Sheepwalks to their junction with the B4391 at OS map ref SJ 017306.

The area excludes any part of a road, footpath, river or body of water by references to which its boundary is defined".

EXPLANATORY NOTE

(This Note is not part of the Order.)

The Food Protection (Emergency Prohibitions) (Wales) Order 1986 ("the principal order") as amended by the Food Protection (Emergency Prohibitions) (Wales) Amendment Order 1986 contains emergency prohibitions restricting various activities in order to prevent human consumption of food which has been or which may have been rendered unsuitable for that purpose in consequence of the escape of radioactive substances from a nuclear reactor situated at Chernobyl in the USSR.

This order excepts from the restrictions imposed by the principal order those sheep which were in that part of the designated area described in the Schedule on 29th August 1986; in consequence any sheep which have been moved from that area before that date remain subject to the restrictions imposed by the principal order and, in particular, may not be slaughtered, anywhere in the United Kingdom, for human consumption or for use in the preparation of feeding stuffs.
