**1986 No. 1874 (C. 67) (S. 134)****ROAD TRAFFIC****The Transport Act 1982 (Scotland) (Commencement No. 2)  
Order 1986***Made - - - - 28th October 1986*

The Secretary of State, in exercise of the powers conferred on him by section 76(2) of the Transport Act 1982(a), and of all other powers enabling him in that behalf, hereby makes the following order:-

**1.**—(1) This order may be cited as the Transport Act 1982 (Scotland) (Commencement No. 2) Order 1986.

(2) In this order “the Act” means the Transport Act 1982.

**2.** This order shall extend to Scotland only.

**3.** The provisions of the Act which are referred to in column 1 of the Schedule to this order (which relate to the matters described in column 2 of that Schedule) shall come into force on 1st December 1986.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This order, which extends only to Scotland, brings into force on 1st December 1986 those provisions of the Transport Act 1982 which are referred to in column 1 of the Schedule to the order. The provisions brought into force relate to the imposition of fixed penalties for certain offences in respect of stationary vehicles.
