LONDON GOVERNMENT

The London Government Reorganisation (Designation of Staff) Order 1986

Made--6th March 1986Laid before Parliament10th March 1986Coming into Operation1st April 1986

The Secretary of State for the Environment, in exercise of the powers conferred on him by section 52 of the Local Government Act 1985(a), and of all other powers enabling him in that behalf, hereby makes the following order:—

Citation, commencement and interpretation

1.—(1) This order may be cited as the London Government Reorganisation (Designation of Staff) Order 1986, and shall come into operation on 1st April 1986.

(2) In this order—

"the Act" means the Local Government Act 1985;

"the council" means the Greater London Council;

"the deposited Schedule" means the schedule entitled "Schedule to the London Government Reorganisation (Designation of Staff) Order 1986" prepared in duplicate, signed by the Secretary of State, and deposited as mentioned in article 2:

"designated" means designated for the purposes of section 52 of the Act;

"the Education Authority" means the Inner London Education Authority;

"employee" includes a trainee or apprentice;

"the Fire Authority" means the London Fire and Civil Defence Authority; and

"the principal order" means the Local Government Reorganisation (Designation of Staff) Order 1986(b).

(3) In determining whether a person is within a description set out in this order, no account shall be taken of his temporary secondment or temporary absence from his post—

- (i) for training or any other purpose connected with his usual duties; or
- (ii) pursuant to any statutory or contractual provision applicable to his employment.

Deposited Schedule

2. The deposited Schedule is deposited and available for inspection at all reasonable times at the Department of the Environment, 2, Marsham Street, London SW1, and at the County Hall, London SE1.

Designation of staff to be transferred to the Education Authority

3.— (1) The persons named in each of the sections of Part I of the deposited Schedule listed below, who are at the making hereof employed by the council in the relevant department indicated, are designated for transfer to the Education Authority—

- (2) The persons named in section 4 of Part I of the deposited Schedule, who are at the making hereof employed by the Council to provide quantity surveying services, are designated for transfer to the Education Authority.
- (3) The persons who both at the making hereof and immediately before 1st April 1986 are employed by the council in the Housing Department on the Greater London Maintenance Management Cost Control System are designated for transfer to the Education Authority.
- (4) The persons who both at the making hereof and immediately before 1st April 1986 are employed by the council in the Valuation and Estates Department on duties relating to either—
 - (i) the provision of administrative and financial support on the programme for the development of sites owned by the council acting as the Inner London Education Authority; or
 - (ii) the handling of rent and rates payments on properties owned or occupied by the council acting in that capacity—

or to both of those matters are designated for transfer to the Education Authority.

- (5) Any employee of the council who—
 - (i) has, between 7th February 1986 and the making hereof, assumed duties which would (but for their commencement after the first-mentioned date) have brought him within a description set out in Schedule 1 to the principal order; and who
 - (ii) continues to carry out those duties until immediately before 1st April 1986—

is designated for transfer to the Education Authority.

Designation of staff to be transferred to the London Residuary Body

- 4.—(1) Any employee of the council who immediately before 1st April 1986 occupies in a department named below a post which—
 - (a) is located in a branch or division specified in the first column of the section of Part II of the deposited Schedule mentioned below; and
 - (b) is graded as specified in the second column of that section; and
 - (c) was on 14th February 1986 occupied by an individual named in relation to that grade in the third column—

is designated for transfer to the London Residuary Body.

(2) Any employee of the council who immediately before 1st April 1986 is employed in either the Central Services of the Personnel Department or in the Central Computer Service of the Director General's Department is designated for transfer to the London Residuary Body.

Designation of staff to be transferred to the Fire Authority

5.— (1) Any employee of the council who both at the making hereof and immediately before 1st April 1986 works in the London Fire Brigade in one of the following capacities—

Brigade Press Officer Assistant Press Officer Housekeeper Assistant Housekeeper Messenger—

is designated for transfer to the Fire Authority.

(2) Any person who-

(a) immediately before 1st April 1986 is employed by the council in a post mentioned in sub-paragraph (i) or (ii) of paragraph 1 of Schedule 4 to the principal order; and

(b) has, since 7th February 1986, completed the London Fire Brigade Pre-Entry Training Course—

is designated for transfer to the Fire Authority.

- (3) The persons named in section 1 of Part III of the deposited Schedule, who are at the making hereof employed by the council in the Emergency Planning Unit on duties in connection with the implementation of the Control of Industrial Major Accident Hazards Regulations 1984(a), are designated for transfer to the Fire Authority.
- (4) The persons named in section 2 of Part III of the deposited Schedule, each of whom is at the making hereof employed by the council in the post therein indicated, are designated for transfer to the Fire Authority.

Designation of staff to be transferred to the London Waste Regulation Authority

- 6. Any employee of the council who immediately before 1st April 1986 occupies in the Public Health Engineering Department a post which—
 - (a) is located in a branch or division specified in the first column of Part IV of the deposited Schedule; and
 - (b) is graded as specified in the second column; and
 - (c) was on 1st February 1986 occupied by an individual named in relation to that grade in the third column—

is designated for transfer to the London Waste Regulation Authority.

Designation of staff to be transferred to London borough councils

- 7.—(1) The persons named in section 1 of Part V of the deposited Schedule, who are at the making hereof employed by the Council in the Housing Department on duties relating to housing mobility, are designated for transfer to the Camden Borough Council.
- (2) The persons named in section 2 of Part V of the deposited Schedule, who are at the making hereof employed by the council as a Keeper or a Senior Keeper at Hounslow Heath, are designated for transfer to the Hounslow Borough Council.
- (3) The persons named in section 3 of Part V of the deposited Schedule, who are at the making hereof employed by the council as either Civic Amenities Site Supervisors or Civic Amenities Site Operators, are designated for transfer to the Richmond Borough Council.

Amendments to the principal order

8. The following entries in paragraph 20 of Schedule 2 to the principal order shall be deleted—

EXPLANATORY NOTE

(This note is not part of the order.)

Under section 52 of the Local Government Act 1985, the Secretary of State may designate (either individually or by class or description) employees of the Greater London Council, which is abolished on 1st April 1986, for automatic transfer to an authority inheriting functions or property. Where an employee is so designated, there is no termination of, or change in the terms of, his contract of employment.

The Local Government Reorganisation (Designation of Staff) Order 1986 (S.I. 1986/192) designated some employees of the Greater London Council and of metropolitan county councils. This order makes further designations of Greater London Council staff. Some designations made herein refer to a deposited Schedule, which may be inspected at the Department of the Environment, 2, Marsham Street, London SW1, and at the County Hall, London SE1.

The order transfers staff as follows-
