# The Lancashire and Western Sea Fisheries District (Abolition of Metropolitan County Councils) Order 1986

Made	7th March 1986
Laid before Parliament	11th March 1986
Coming into Operation	1 <i>st April</i> 1986

The Minister of Agriculture, Fisheries and Food, being the appropriate Minister within the meaning of section 270(1) of the Local Government Act 1972(a), and the Secretary of State, in exercise of the power conferred on them by section 101 of the Local Government Act 1985(b) and, in the case of the Minister, by section 103(6) of that Act and of all other powers enabling them in that behalf hereby make the following order:—

1.—(1) This order may be cited as the Lancashire and Western Sea Fisheries District (Abolition of Metropolitan County Councils) Order 1986 and shall come into operation on 1st April 1986.

(2) In this order —

"the Lancashire and Western Sea Fisheries Committee" means the local fisheries committee constituted by the 1900 order; and

"the 1900 order" means the order made by the Board of Trade on 22nd February 1900(c) (which created the Lancashire and Western Sea Fisheries District and constituted a local fisheries committee for the regulation of the sea fisheries within that district).

2.—(1) The 1900 order shall have effect subject to the following provisions.

(2) Until the coming into operation of an order made under the Sea Fisheries Regulation Act 1966(d) further varying or revoking the 1900 order the Lancashire and Western Sea Fisheries Committee shall be a joint committee of the county councils referred to in column 1 of the Schedule to that order, with the exception of Greater Manchester County Council and Merseyside County Council, and accordingly the committee shall consist of 34 members.
