**The River Tummel Catchment Area Protection (Renewal)  
Order 1986**

*Made* - - - - - 6th March 1986

*Coming into Operation* 15th March 1986

The Secretary of State, in exercise of the powers conferred on him by section 1(7) of the Freshwater and Salmon Fisheries (Scotland) Act 1976(a) and of all other powers enabling him in that behalf, hereby makes the following order:-

*Citation and commencement*

1. This order may be cited as the River Tummel Catchment Area Protection (Renewal) Order 1986 and shall come into operation on 15th March 1986.

*Interpretation*

2. In this order, unless the context otherwise requires -

“freshwater fish” has the same meaning as in section 24(1) of the Salmon and Freshwater Fisheries (Protection) (Scotland) Act 1951(b); and

“the 1983 Order” means the River Tummel Catchment Area Protection Order 1983(c).

*Renewal of order*

3. The 1983 Order is hereby renewed.

*Prohibition*

4. During the period from 15th March 1986 to 6th October 1988, both dates inclusive, fishing for or taking freshwater fish in the inland waters in the area prescribed in article 4 of the 1983 Order, without legal right or without written permission from a person having such a right is hereby prohibited.

## EXPLANATORY NOTE

(This Note is not part of the Order.)

This order renews the River Tummel Catchment Area Protection Order 1983 which prohibited fishing for or taking freshwater fish in inland waters in the area prescribed in that order without legal right or without written permission from a person having such a right. The effect of the renewal is that the prohibition has effect from 15th March 1986 to 6th October 1988.

The prescribed area referred to is the whole of the catchment area of the River Tummel upstream from its confluence with the River Tay at Ballinluig which area lies within the Tayside, Highland and Strathclyde Regions but excluding that part of the catchment area of Loch Ericht lying within Highland region. The area is illustrated on a map attached to the 1983 Order and is defined by reference to a large scale map which may be inspected at Chesser House, Gorgie Road, Edinburgh on any working day between 8.30a.m. and 4.30p.m.
