EXPLANATORY NOTE

(This note is not part of the Rules)

These Rules amend the Lands Tribunal for Scotland Rules 1971 for two purposes -

- to increase the fees payable to the Tribunal other than for items 5(a)(ii) in part and (b)(ii) in part (hearing fees), and items 7,8 and 9 (miscellaneous fees) of the Schedule; and
- (2) to impose a fee for the first time on the Tribunal making an order under section 1 of the Conveyancing and Feudal Reform (Scotland) Act 1970 (item 4(b) of the Schedule).
