The Registration of Births, Deaths and Marriages (Fees) Order 1988

Made	8th February 1988
Laid before Parliament	15th February 1988
Coming into force	1st April 1988

The Secretary of State for Social Services in exercise of the powers conferred by section 5(1) and (2) of, and paragraphs 1 and 2 of Schedule 3 to, the Public Expenditure and Receipts Act 1968(a) and now vested in him(b) and of all other powers enabling him in that behalf, hereby makes the following order:

Citation and commencement

1. This Order may be cited as the Registration of Births, Deaths and Marriages (Fees) Order 1988 and shall come into force on 1st April 1988.

Fees payable

2. The fees payable under each of the enactments specified in column 2 of the Schedule to this Order in respect of the matters specified in column 3 shall be the fees specified in relation thereto in column 4 and each of those enactments shall have effect accordingly.

Revocation of Order

3. The provisions of this Order shall have effect in place of the provisions of the Registration of Births, Deaths and Marriages (Fees) Order 1987(c) (under which the fees payable were as respectively set out in column 5 of the Schedule to this Order) and that Order is accordingly revoked.
