The Sludge (Use in Agriculture) Regulations 1989

Supply of information about sludge

7.—(1) A sludge producer shall make the register maintained under regulation 6 available for inspection by [^{F1}the Environment Agency][^{F2}or, in Scotland, the Scottish Environment Protection Agency][^{F3}or, in Wales, the Natural Resources Body for Wales] at all reasonable times; and shall furnish [^{F1}the Environment Agency][^{F2}or, in Scotland, the Scottish Environment Protection Agency][^{F3}or, in Wales, the Natural Resources Body for Wales] with such information or facilities as [^{F4}it] may reasonably require relating to (or to verifying the information contained in) the register or otherwise relating to sludge supplied by the sludge producer, including facilities for analysis of representative samples of sludge or soil.

(2) As soon as reasonably practicable after testing sludge in accordance with Schedule 1, the sludge producer shall provide details of the analysis made under that Schedule to all persons to whom the sludge producer supplies sludge.
