The Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1990

The Secretary of State, in exercise of the powers conferred on him by section 5 of and Schedule 3 to the Public Expenditure and Receipts Act 1968(a) and of all other powers enabling him in that behalf, hereby makes the following Order:

Citation, extent and commencement

1. This Order may be cited as the Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1990, shall apply to Scotland only and shall come into force on 1st April 1991.

Fees

2. The fees payable under the enactments specified in column 1 of the Schedule to this Order in respect of the certificates described in column 2 of that Schedule shall (in place of the amounts previously prescribed which are specified in column 3 thereof(b) be respectively the amounts specified in column 4 thereof.

Revocation

3. The Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1989(c) is hereby revoked.
