 - "(5) Where a person is shown before the first day of chargeable financial year in a charging authority's register as becoming subject to a community charge of the authority on that first day, the authority shall as soon as reasonably practicable after the day on which it first sets its community charges for that year or, if later, the first day on which he is so shown, serve on that person a demand notice for the relevant year."

 - (i) omit the words "or during"
 - (ii) after the words "register as" insert the word "becoming"; and
 - (iii) for the words "day on which the notice is issued" substitute the words "first day of the relevant year"; and
