The Disability Living Allowance and Disability Working Allowance (Consequential Provisions) Regulations 1991

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Disability Living Allowance and Disability Working Allowance (Consequential Provisions) Regulations 1991 and shall, subject to paragraph (2), come into force on 6th April 1992.

(2) Regulation 11 shall come into force in relation to a particular claimant at the beginning of the first benefit week to commence for that claimant on or after the date specified in paragraph (1); and for this purpose the expressions “claimant” and “benefit week” have the same meanings as in the Income Support (General) Regulations 1987^{M1}.

(3) In these Regulations—
