**The Cornwall and Isles of Scilly Mental Handicap National
Health Service Trust (Change of Name) Order 1993**

Made - - - - *14th April 1993*
Coming into force - - *24th April 1993*

The Secretary of State for Health, in exercise of powers conferred on her by section 126(3) and (4) of the National Health Service Act 1977⁽¹⁾ and section 5(1) of the National Health Service and Community Care Act 1990⁽²⁾ and of all other powers enabling her in that behalf hereby makes the following Order—

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Cornwall and Isles of Scilly Mental Handicap National Health Service Trust (Change of Name) Order 1993 and shall come into force on 24th April 1993.

(2) In this Order unless the context otherwise requires—

“the Order” means the Cornwall and Isles of Scilly Mental Handicap National Health Service Trust (Establishment) Order 1990⁽³⁾;

“the trust” means the National Health Service trust established by the Order.

Change of name of NHS trust

2. The trust shall be called The Cornwall and Isles of Scilly Learning Disabilities National Health Service Trust instead of the Cornwall and Isles of Scilly Mental Handicap National Health Service Trust, and accordingly in article 1 of the Order in the definition of “the trust” and in article 2 of the Order for the words “Mental Handicap” there shall be substituted the words “Learning Disabilities”.

Transitional provisions

3. The change of name under this Order shall not—
