**REGISTRATION OF BIRTHS, DEATHS,
MARRIAGES, ETC. ENGLAND AND WALES**

The Registration of Births, Deaths
and Marriages (Fees) Order 1993

The Secretary of State for Health, in exercise of the powers conferred by section 5(1) and (2) of, and paragraphs 1 and 2 of Schedule 3 to, the Public Expenditure and Receipts Act 1968⁽¹⁾ and now vested in her⁽²⁾ and of all other powers enabling her in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Registration of Births, Deaths and Marriages (Fees) Order 1993 and shall come into force on 1st April 1994.

Fees payable

2. The fees payable in England and Wales under each of the enactments specified in column 2 of the Schedule to this Order in respect of the matters specified in column 3 shall be the fees specified in relation thereto in column 4 and each of those enactments shall have effect accordingly.

(2) Article 2 of the Secretary of State for Social Services Order (see S.I. 1968/1699) transferred all functions of the Minister of Health to the Secretary of State for Social Services and article 2(1) of the Transfer of Functions (Health and Social Security) Order 1988 (see S.I. 1988/1843) transferred certain of those functions, including those in relation to registration of births, deaths and marriages to the Secretary of State for Health.

Revocation of Orders

3. The provisions of this Order shall have effect in place of the provisions of the Registration of Births, Deaths and Marriages (Fees) (No. 2) Order 1992⁽³⁾ and the Registration of Births, Deaths and Marriages (Amendment) (No.2) Order 1993⁽⁴⁾ (under which the fees payable were as respectively set out in column 5 of the Schedule to this Order) and those Orders are accordingly revoked.
