Her Majesty, in pursuance of section 5(9) of the Parliamentary Commissioner Act 1967⁽¹⁾, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. This Order may be cited as the Parliamentary Commissioner Order 1996 and shall come into force on 23rd August 1996.
