Citation and interpretation

- 1.—(1) This Order may be cited as the Pensions Act 1995 (Commencement No. 9) Order 1997.
- (2) In this Order "the Act" means the Pensions Act 1995.

Appointed days

- **2.**—(1) The day appointed for the coming into force of section 80(4) of the Act (review of decisions of the Pensions Compensation Board), paragraph 12 of Schedule 2 to the Act and section 78(8) of the Act insofar as it relates to that paragraph (proceedings of the Pensions Compensation Board)—
 - (a) for the purpose only of authorising the making of regulations, is 4th February 1997, and
 - (b) for all other purposes, is 6th April 1997.
- (2) The day appointed for the coming into force of section 55 of the Act (end of annual increase in GMP) is 4th February 1997.
