**The Cornwall and Isles of Scilly Health Authority
(Transfers of Trust Property) Order 1998**

The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the changes in the arrangements for the administration of hospitals and other establishments and facilities resulting from the establishment of the National Health Service trusts specified in the Schedule to this Order, having consulted the Cornwall and Isles of Scilly Health Authority and those National Health Service trusts in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Cornwall and Isles of Scilly Health Authority (Transfers of Trust Property) Order 1998 and shall come into force on 29th October 1998.

(2) In this Order—

“the Authority” means the Cornwall and Isles of Scilly Health Authority;

“the Schedule” means the Schedule to this Order;

“the trust property” means, in the case of each National Health Service trust specified in the Schedule, the items specified in a schedule of trust property prepared by, agreed upon by and signed on behalf of the Authority and that National Health Service trust on 12th May 1998.

Transfer of trust property

2. On 29th October 1998, in the case of each National Health Service trust specified in the Schedule, the trust property shall be transferred from the Authority to that National Health Service trust.
