## SCHEDULE 1

Regulation 3(1)

### INCIDENTAL AND CONSEQUENTIAL AMENDMENTS

#### *The Telecommunications Act 1984*

1. In section 1(6) of the Telecommunications Act 1984<sup>(1)</sup> (payment out of money provided by Parliament) for the words following “by any of his staff” there shall be substituted the following words—

“in consequence of the provisions of—

- (a) this Act;
- (b) the Telecommunications (Open Network Provision) (Voice Telephony) Regulations 1998; or
- (c) the Telecommunications (Data Protection and Privacy) (Direct Marketing) Regulations 1998.”.
