**The Bethlem and Maudsley, the Lambeth
Healthcare, the Lewisham and Guy's Mental
Health and the Optimum Health Services National
Health Service Trusts (Dissolution) Order 1999**

Made - - - - *18th March 1999*

Coming into force - - *1st April 1999*

The Secretary of State for Health, in exercise of the powers conferred on him by section 126(3) of the National Health Service Act 1977⁽¹⁾ and by section 5(1) of, and paragraph 29(1) of Schedule 2 to, the National Health Service and Community Care Act 1990⁽²⁾ and of all other powers enabling him in that behalf, considering it appropriate in the interests of the health service to make this Order⁽³⁾, and after completion of the consultation prescribed under paragraph 29(3) of Schedule 2 to the latter Act⁽⁴⁾, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as The Bethlem and Maudsley, the Lambeth Healthcare, the Lewisham and Guy's Mental Health and the Optimum Health Services National Health Service Trusts (Dissolution) Order 1999 and shall come into force on 1st April 1999.

Dissolution of NHS trusts

2.—(1) The Bethlem and Maudsley National Health Service Trust established by The Bethlem and Maudsley National Health Service Trust (Establishment) Order 1994⁽⁵⁾ shall be dissolved on 1st April 1999, and accordingly that Order revoked on that date.

(2) The Lambeth Healthcare National Health Service Trust established by The West Lambeth Community Care National Health Service Trust (Establishment) Order 1991⁽⁶⁾ shall be dissolved on 1st April 1999, and accordingly that Order revoked on that date.

(3) The Lewisham and Guy's Mental Health National Health Service Trust established by The South East London Mental Health National Health Service Trust (Establishment) Order 1993⁽⁷⁾ shall be dissolved on 1st April 1999, and accordingly that Order revoked on that date.

(4) The Optimum Health Services National Health Service Trust established by The Optimum Health Services National Health Service Trust (Establishment) Order 1991⁽⁸⁾ shall be dissolved on 1st April 1999, and accordingly that Order revoked on that date.
