Statement of the Education Committee

3. The Committee shall publish a statement, and may from time to time amend the statement, indicating—

(a) matters on which the Committee will wish to be satisfied before advising the General Council to recognise a qualification under subsection (2) of section 14 of the Act; and

(b) matters which may cause the Committee to advise the General Council not to recognise a qualification under that subsection.

Non-United Kingdom Qualifications

- 4. A person who—
- (a) has obtained a qualification in osteopathy outside the United Kingdom;
- (b) does not hold a recognised qualification(b); but
- (c) satisfies the Registrar that he has reached the required standard of proficiency

shall be treated as holding a recognised qualification for the purposes of the Act.
