**The GLA Side Roads (London Borough
of Sutton) Designation Order 2000**

Whereas the Secretary of State for the Environment, Transport and the Regions considers it appropriate for certain roads in the London borough of Sutton to be GLA side roads in the interests of the management of traffic and the control of the waiting and loading of vehicles on or in the immediate vicinity of GLA roads:

Now therefore the Secretary of State in exercise of the powers conferred by section 124A of the Road Traffic Regulation Act 1984(1) hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the GLA Side Roads (London Borough of Sutton) Designation Order 2000 and shall come into force on 19th June 2000.

Designation of GLA side roads

2.—(1) The roads in the London borough of Sutton specified in the Schedule to this Order are hereby designated as GLA side roads(2).

(2) The description of a road includes the intersection of that road and any other road that crosses it at the same level.

(3) In the Schedule “m” means metres.

(4) In accordance with section 124A(2) of the Road Traffic Regulation Act 1984, 3rd July 2000 is hereby specified as the date on which the designated roads are to become GLA side roads.

(1) 1984 c. 27; section 124A was inserted by section 272 of the Greater London Authority Act 1999 (c. 29).

(2) For the definition of GLA side road, see the Road Traffic Regulation Act 1984 sections 124A(9) and 142 (amended by the Greater London Authority Act 1999 section 292(3)).

ROADS IN THE LONDON BOROUGH OF SUTTON DESIGNATED AS GLA SIDE ROADS

Roads in the vicinity of A24

1. Ash road between its junction with Stonecot Hill (A24) and a point 20.5m north west of the common boundary of 101 and 103 Ash Road.
2. Burleigh Road between its junction with Stonecot Hill (A24) and a point 22.5m north west of the common boundary of 87 and 89 Burleigh Road.
3. Cheam Common Road—
 - (a) (south west side) between its junction with London Road (A24) and a point 7m north west of the party wall between 7 and 9 Cheam Common Road;
 - (b) (north east side) between its junction with London Road (A24) and a point 1m south east of the common boundary of 26 and 28 Cheam Common Road.
4. Clarkes Avenue between its junction with London Road (A24) and a point 23m south east of the common boundary of 11 and 13 Clarke’s Avenue.
5. Courtenay Road between its junction with London Road (A24) and a point 23m south east of the common boundary between 2 and 4 Courtenay Road.
6. Elm Road West between its junction with Epsom Road (A24) and a point 1.5m north west of the rear boundary wall of 91 Epsom Road.
7. Gander Green Lane between its junction with London Road (A24) and a point 11m south east of the common boundary between 575 and 577 Gander Green Lane.
8. Garth Road between its junction with Stonecot Hill (A24) and a point 12.5m south east of the common boundary of 2 and 4 Garth Road measured perpendicular to the north eastern kerbline.
9. Glyn Road between its junction with London Road (A24) and a point 10.5m south east of the south eastern front wall of 629 London Road.
10. Hamilton Avenue between its junction with London Road (A24) and a point 1m south east of the common boundary between 234 and 236 Hamilton Avenue.
11. Hill Top between its junction with Stonecot Hill (A24) and a point 16m north west of the common boundary of 1 and 3 Hill Top.
12. Kingsbridge Road between its junction with Stonecot Hill (A24) and a point 21.5m south east of the common boundary between 2 and 4 Kingsbridge Road measured perpendicular to the north eastern kerbline of Kingsbridge Road.
13. Kingsmead Avenue between its junction with London Road (A24) and a point 29.5m south east of the common boundary between 2 and 4 Kingsmead Avenue.
14. Langley Avenue between its junction with London Road (A24) and a point 21m south east of the common boundary of 2 and 4 Langley Avenue.
15. Lavender Avenue between its junction with London Road (A24) and a point 25m south east of the common boundary between 1 and 3 Lavender Avenue.
16. Lloyd Road between its junction with London Road (A24) and a point 25m south east of the common boundary of 1 and 3 Lloyd Road.
17. Malden Road—

Status: This is the original version (as it was originally made). This item of legislation is currently only available in its original format.

- (a) (south west side) between its junction with London Road (A24) and a point 4m south east of the party wall between 277 and 279 Malden Road;
 - (b) (north east side) between its junction with London Road (A24) and a point 5.5m south east of a point opposite the party wall between 281 and 283 Malden Road.
- 18.** Lower Morden Lane (south west side) between its junction with Epsom Road (A24) and a point 11.5m south east of the common boundary between 1 and 3 Lower Morden Lane measured perpendicular to the south western kerbline.
- 19.** Nova Mews between its junction with Stonecot Hill (A24) and a point 10m north west of the extended kerbline of Stonecot Hill (A24).
- 20.** Oaks Avenue—
- (a) (south west arm) between its junction with London Road (A24) and a point 3.5m south east of the common boundary of 1 and 3 Oaks Avenue;
 - (b) (north west arm) between its junction with London Road (A24) and a point opposite the common boundary of 2 and 4 Oaks Avenue measured perpendicular to the north western kerbline.
- 21.** Palmer Avenue between its junction with London Road (A24) and a point 25m north west of the common boundary of 78 and 80 Palmer Avenue.
- 22.** Ridge Road between its junction with Stonecot Hill (A24) and a point 35m north west of the common boundary of 232 and 234 Ridge Road.
- 23.** Senhouse Road between its junction with London Road (A24) and a point 13.5m north west of the common boundary of 1 and 3 Senhouse Road.
- 24.** Staines Avenue between its junction with London Road (A24) and a point 3m north west of the common boundary between 2 and 4 Staines Avenue.
- 25.** Stonecot Close between its junction with Stonecot Hill (A24) and a point 13.5m north west of the common boundary between 25 and 26 Stonecot Close.
- 26.** Sutton Common Road between its junction with Epsom Road (A24) and a point 4.5m south east of the common boundary of 486 and 488 Sutton Common Road.
- 27.** The Spinney between its junction with London Road (A24) and a point 10.5m south east of the south eastern kerbline of London Road.
- 28.** Trafalgar Avenue between its junction with London Road (A24) and a point 5m south east of the north western flank wall of the Lord Nelson public house, London Road.
- 29.** Tudor Avenue—
- (a) (south west arm) between its junction with London Road (A24) and a point 2m south east of the common boundary of 1 and 3 Tudor Avenue;
 - (b) (north west arm) between its junction with London Road (A24) and a point 3m north east of the common boundary of 2 and 4 Tudor Avenue.
- 30.** Tudor Drive between its junction with Stonecot Hill (A24) and the borough boundary with the London Borough of Merton.
- 31.** Unnamed access road (serving Sainsbury's plc) between its junction with London Road (A24) and the highway boundary.
- 32.** Unnamed road known as the access to St. Anthony's Hospital between its junction with London Road (A24) and the limit of the public highway.

33. Wellesley Court between its junction with Stonecot Hill (A24) and a point 2.5m north west of the north western front wall of 95 Stonecot Hill.

34. Wickham Avenue between its junction with London Road (A24) and a point 32m north west of the common boundary of 168 and 170 Wickham Avenue.

35. Willowhayne Gardens between its junction with London Road (A24) and a point 8.5m south east of the south eastern front wall of 477 London Road measured perpendicular to the north eastern kerbline of Willowhayne Gardens.

36. Wordsworth Drive between its junction with London Road (A24) and a point 19.5m north west of the north western flank wall of Sidmouth Court, Wordsworth Drive.

Roads in the vicinity of A217

37. Abbotts Road between its junction with St. Dunstan's Hill (A217) and a point 6m north east of the common boundary of 11 and 13 Abbotts Road.

38. Alberta Avenue—

(a) (north west side) between its junction with St. Dunstan's Hill (A217) and a point 41m south west of the common boundary of 116 and 118 Alberta Avenue;

(b) (south east side) between its junction with St. Dunstan's Hill (A217) and a point 26m south west of the south western boundary wall of 183 Alberta Avenue.

39. Alcorn Close between its junction with Sutton Common Road and a point 1m north east of the north eastern wall of the Youth Centre, Sutton Common Road measured perpendicular to the north western kerbline.

40. Alma Crescent between its junction with St. Dunstan's Hill (A217) and a point 11.5m south west of the south western boundary of 1a Alma Crescent.

41. Arundel Road—

(a) (west side) between its junction with Belmont Rise (A217) and a point 10m south west of the extended kerbline of Belmont Rise;

(b) (east side) between its junction with Belmont Rise (A217) and a point 7.5m south west of the common boundary of 23 and 25 Arundel Road.

42. Beresford Road—

(a) (west side) between its junction with Belmont Rise (A217) and a point 5m north of a point opposite the common boundary of 87 and 89 Beresford Road;

(b) (east side) between its junction with Belmont Rise (A217) and a point opposite the common boundary of 89 and 91 Beresford Road.

43. Bishopsford Road—

(a) (north west side) between its junction with Rose Hill Roundabout (A217) and a point 5m north east of a point opposite the party wall between 25 and 26 Rosehill Court;

(b) (south east side) between its junction with Rose Hill Roundabout (A217) and a point 8m south west of the party wall between 325 and 327 Bishopsford Road.

44. Burdon Lane (east side)—

(a) (northern arm) between its junction with Northey Avenue and a point 62m south east of the common boundary of 75 and 77 Burdon Lane;

(b) (southern arm) between its junction with Northey Avenue and a point 14m north west of the common boundary of 85 and 87 Burdon Lane.

- 50.** Glastonbury Road between its junction with Reigate Avenue (A217) and a point 18m south east of the common boundary of 197 and 199 Glastonbury Road.
- 51.** Green Lane—
- (a) (north arm) between its junction with Rose Hill Roundabout (A217) and a point 15m south east of the party wall between 13-17 and 8-12 Goodson House, St. Helier Avenue;
 - (b) (south arm) between its junction with Rose Hill Roundabout (A217) and a point 1.5m north east of the party wall between 26-30 and 31-35 Cheshire House, Reigate Avenue.
- 52.** Lumley Road between its junction with St. Dunstan's Hill (A217) and a point 3.5m south east of the common boundary between 42 and 44 Lumley Road.
- 53.** Northdown Road—
- (a) (western arm) between its junction with Belmont Rise (A217) and a point 5m east of the common boundary of 21 and Carpe Diem, Northdown Road;
 - (b) (eastern arm) between its junction with Belmont Rise (A217) and a point 7.5m west of the common boundary of 6 and 7 Northdown Road.
- 54.** Northey Avenue between its junction with Belmont Rise (A217) and its junction with Burdon Lane.
- 55.** Rose Hill—
- (a) (east side) between its junction with Rose Hill Roundabout (A217) and its junction with The Market service road;
 - (b) (west side) between its junction with Rose Hill Roundabout (A217) and a point 7m north east of a point opposite the party wall between 53-54 and 55 The Market, Rose Hill.
- 56.** Salisbury Avenue between its junction with Belmont Rise (A217) and a point opposite the rear common boundary of 43 and 45 Summerville Gardens measured perpendicular to the north eastern kerbline.
- 57.** Stayton Road between its junction with Oldfields Road (A217) and a point opposite the common boundary of 166 and 168 Stayton Road.
- 58.** Sunningdale Road between its junction with Gander Green Lane and a point 24m north east of the south western boundary wall of 283 Gander Green Lane.
- 59.** Sutton Common Road—

- (a) (eastern arm) between its junction with Oldfields Road (A217) and a point opposite the common boundary of 174 and 176 Sutton Common Road;
 - (b) (western arm) between its junction with Oldfields Road (A217) and a point 1m south east of the common boundary of 234 and 236 Sutton Common Road.
- 60.** The Crescent—
- (a) (eastern arm) between its junction with Belmont Rise (A217) and a point 23m south west of the common boundary of 47 and 49 The Crescent measured perpendicular to the north western kerbline;
 - (b) (western arm) between its junction with Belmont Rise (A217) and a point 4.5m north east of the common boundary of 59 and 61 The Crescent measured perpendicular to the north western kerbline.
- 61.** Unnamed road known as the Tesco superstore access road between its junction with Oldfields Road (A217) and the limit of the public highway.
- 62.** Unnamed road known as the A217/A24 Link Road between its junction with Oldfields Road (A217) and a point 78m north west of the extended kerbline of Oldfields Road.
- 63.** Wrythe Lane—
- (a) (north east side) between its junction with Rose Hill roundabout (A217) and a point 8m south east of a point opposite the party wall between 304 and 306 Wrythe Lane;
 - (b) (south west side) between its junction with Rose Hill roundabout (A217) and a point opposite the party wall between 25 and 26 The Market, Wrythe Lane;
 - (c) Service Road, Wrythe Lane between its junction with Wrythe Lane opposite 326 Wrythe Lane south eastwards to a point 8m south east of the party wall between 304 and 306 Wrythe Lane.

- 88.** Demesne Road between its junction with Croydon Road (A232) and a point 8.5m north west of the common boundary of 264 and 266 Demesne Road.
- 89.** Derby Road between its junction with Cheam Road (A232) and a point 34m north west of the north western boundary wall of 1 Derby Road measured perpendicular to the south western kerblines.

90. Derek Avenue between its junction with Croydon Road (A232) and a point 13m south of the common boundary between 1 and 3 Derek Avenue.

91. Fairholme Road between its junction with Cheam Road (A232) and a point 36m south of the southern boundary of 1 Fairholme Road.

92. Gander Green Lane—

(a) (west side) between its junction with Cheam Road (A232) and a point 4m south west of the common boundary between 1 and 3 Gander Green Lane measured perpendicular to the north western kerblines;

(b) (east side) between its junction with Cheam Road (A232) and a point opposite a point 3m south west of the common boundary between 1 and 3 Gander Green Lane.

93. Gibson Road between its junction with Cheam Road (A232) and a point 9m north west of the extended line of the north western kerblines of Cheam Road measured along the south western kerblines.

94. Garrett Close between its junction with Croydon Road (A232) and a point 3m north of the southern boundary of 146 Croydon Road.

95. Grove Avenue between its junction with Cheam Road (A232) and a point 10m north west of the north western front wall of 91 Cheam Road.

96. Grove Road between its junction with Sutton Park Road (A232) and a point 9m north east of the north eastern flank wall of 1 to 10 Homefield Park measured perpendicular to the north eastern kerblines.

97. Hallowell Avenue (south side) between its junction with Bridges Lane and a point 3m west of the western kerblines of Bridges Lane.

98. Harcourt Road between its junction with Croydon Road (A232) and a point 4m north west of the north west front wall of 359 Croydon Road.

99. Harrow Road between its junction with Carshalton Road (A232) and a point 10m north east of the north eastern boundary wall of 78 to 80 Harrow Road measured perpendicular to the south eastern kerblines.

100. Highfield Road between its junction with Carshalton Road (A232) and the extended line of the south western flank wall of 5 to 6 Brindley House, Highfield Road.

101. High Street, Sutton—

(a) (north arm) between its junction with Carshalton Road (A232) and the common boundary between 54 and 56 High Street, Sutton;

(b) (middle arm)

(i) between its junction with Carshalton Road (A232) and a point 4m south of the northern boundary of 37 High Street, Sutton;

(ii) (west side) between its junction with Grove Road (A232) and the party wall between 17 to 19 and 21 High Street, Sutton;

(iii) (east side) between its junction with Sutton Court Road (A232) and a point 2m north of the southern flank wall of 26 High Street, Sutton;

124. Revel Road between its junction with Cheam Road (A232) and a point 15m south east of the common boundary of 160 Cheam Road and 1 Revel Road.

125. Ringstead Road between its junction with Carshalton Road (A232) and a point 16m south of the southern boundary of 1 Ringstead Road.

126. Roberts Close between its junction with Ewell Road (A232) and a point 10m north west of the extended line of the north eastern kerblines of Ewell Road.

127. Rosebery Road between its junction with Cheam Road (A232) and a point 38m north west of the north western boundary wall of 1 Rosebery Road measured perpendicular to the south western kerblines.

128. Rotherfield Road—

- (a) (west side) between its junction with High Street, Carshalton (A232) and a point opposite a point 18m north west of the common boundary between 3 and 5 Rotherfield Road;
- (b) (east side) between its junction with High Street, Carshalton (A232) and a point 30m north west of the common boundary between 1 and 3 Rotherfield Road.

129. St. Barnabas Road between its junction with Carshalton Road (A232) and a point 1m north east of the party wall of 1 and 3 St. Barnabas Road.

130. St. James Road—

- (a) (north arm)
 - (i) (west side) between its junction with Cheam Road (A232) and a point 25m south east of the south eastern boundary of 27 St James Road;
 - (ii) (east side) between its junction with Cheam Road (A232) and a point 27m south east of the south eastern boundary of 27 St. James Road.
- (b) (south arm)
 - (i) (west side) between its junction with Cheam Road (A232) and a point 33m north of the northern boundary wall of 23a St. James Road;
 - (ii) (east side) between its junction with Cheam Road (A232) and a point opposite a point 32m north of the northern boundary wall of 23a St. James Road.

131. St. Nicholas Way—

- (a) (east side) between its junction with Cheam Road (A232) and a point 10m south east of the north western rear wall of the Civic Centre, St. Nicholas Way measured perpendicular to the south western kerblines;
- (b) (west side) between its junction with Cheam Road (A232) and a point 3m south east of its junction with Gibson Road.

132. Salcott Road between its junction with Croydon Road (A232) and a point 38m south of the northern boundary of 102 Croydon Road.

133. Sandhills between its junction with Croydon Road (A232) and a point 4m north east of the common boundary of 1 and 3 Sandhills measured perpendicular to the south eastern kerblines.

134. Sherwood Park Road—

Status: This is the original version (as it was originally made). This item of legislation is currently only available in its original format.

- (a) (west side) between its junction with Cheam Road (A232) and a point 7m south east of a point opposite the common boundary of 2 and 4 Sherwood Park Road;
 - (b) (east side) between its junction with Cheam Road (A232) and a point 9m south of the common boundary between 2 and 4 Sherwood Park Road.
- 135.** Shorts Road between its junction with Carshalton Road (A232) and a point 35m south of the southern boundary of 1 Shorts Road.
- 136.** Station Way—
- (a) (west side) between its junction with Ewell Road (A232) and a point 21m south of the common boundary between 16 and Century House, Station Way;
 - (b) (east side) between its junction with High Street, Cheam (A232) and a point 7m north of the common boundary between 15 to 19 and 21 Station Way.
- 137.** Streeters Lane between its junction with Croydon Road (A232) and a point 68m south of the north western boundary wall of Sherwood Park School, Streeters Lane.

- 140.** Sutton Grove between its junction with Carshalton Road (A232) and a point 40m south of the southern flank wall of 13 to 24 Relko Gardens, Sutton Grove.
- 141.** The Broadway, Beddington.
- 142.** The Broadway, Cheam between its junction with Ewell Road (A232) and the common boundary of 21 and 23 The Broadway.
- 143.** The Holt between its junction with Croydon Road (A232) and a point 20m north west of the common boundary of 1 and 2 The Holt.
- 144.** The Manor Way between its junction with Croydon Road (A232) and a point 1m south east of the north western front wall of 329 Croydon Road.
- 145.** The Square between its junction with High Street, Carshalton (A232) and a point 20m south east of the extended line of the north western front wall of 14 High Street, Carshalton.
- 146.** Throwley Way between its junction with Carshalton Road (A232) and a point 18m south east of the extended line of the south eastern kerblines of Throwley Road.
- 147.** Victoria Road between its junction with Carshalton Road (A232) and a point 2m north west of the party wall between 2a and 2b Victoria Road.
- 148.** Wallace Crescent between its junction with Pound Street (A232) and a point 2m north west of the southern boundary of 61 Pound Street.
- 149.** Weihurst Gardens between its junction with Carshalton Road (A232) and a point 15m north of the southern boundary of 280 Carshalton Road.
- 150.** Westcroft Road between its junction with High Street, Carshalton (A232) and a point 3m north east of the north eastern flank wall of Westcroft, Westcroft Road.
- 151.** Western Road between its junction with Cheam Road (A232) and a point 27m south of the common boundary between 1 and 1a Western Road.

152. West Street between its junction with Pound Street (A232) and a point 49m south east of the south eastern boundary of the Old Rectory, West Street.

153. Willoughby Avenue between its junction with Croydon Road (A232) and a point 38m north of the southern boundary of 71 Croydon Road.

154. Wilmot Road—

- (a) (north east side) between its junction with Pound Street (A232) and a point 6m south east of the south eastern boundary wall of 91 Pound Street measured perpendicular to the north eastern kerblines;
- (b) (south west side) between its junction with Pound Street (A232) and a point 4m south east of the south eastern boundary wall of 91 Pound Street measured perpendicular to the north eastern kerblines.

155. Wright's Row (north side) between its junction with Manor Road and a point 5m west of the extended kerblines of Manor Road.

156. York Road between its junction with Cheam Road (A232) and a point 52m north west of the north western rear boundary wall of 2 Derby Road measured perpendicular to the south western kerblines.

EXPLANATORY NOTE

(This note is not part of the Order)

Section 272 of the Greater London Authority Act 1999 inserts a new section 124A into the Road Traffic Regulation Act 1984 whereby the Secretary of State may designate roads or proposed roads which are to be GLA side roads, for which Transport for London will be the traffic authority. This Order designates the roads in the London Borough of Sutton specified in the Schedule as GLA side roads with effect from 3rd July 2000.
