INVESTIGATORY POWERS

**The Regulation of Investigatory Powers (Covert
Surveillance: Code of Practice) Order 2002**

Made - - - - - *22nd July 2002*

Coming into force - - - *1st August 2002*

Whereas—

(1) in pursuance of section 71 of the Regulation of Investigatory Powers Act 2000^(a) (“the 2000 Act”) the Secretary of State is under a duty to prepare codes of practice containing provisions relating to the exercise and performance of the powers and duties mentioned in subsection (2) of that section;

(2) in pursuance of section 71(3) of the 2000 Act the Secretary of State published the code prepared by him under section 71 of the 2000 Act relating to covert surveillance under Part II of the 2000 Act in the form of a draft and has considered representations made to him about the draft and modified the draft accordingly;

(3) in pursuance of section 71(4) of the 2000 Act the Secretary of State has laid that code before both Houses of Parliament;

(4) a draft of this Order has been laid before Parliament and approved by a resolution of each House;

Now, therefore, the Secretary of State, in exercise of the powers conferred on him by section 71(5) of the 2000 Act, hereby makes the following Order:

Citation and commencement

1. The Order may be cited as the Regulation of Investigatory Powers (Covert Surveillance: Code of Practice) Order 2002 and shall come into force on 1st August 2002.

Covert Surveillance Code of Practice

2. The draft code of practice entitled “Covert Surveillance”, laid before each House of Parliament on 10th June 2002, relating to covert surveillance under Part II of the 2000 Act, shall come into force on 1st August 2002.
