GENERAL OPTICAL COUNCIL

The Registration and Enrolment (Amendment) Rules 2003

In pursuance of their powers under section 10 of the Opticians Act 1989, the General Optical Council hereby make the following rules:

- 1. These rules may be cited as the Registration and Enrolment (Amendment) Rules 2003.
- **2.** In the Registration and Enrolment Rules 1976 (which in their original form are scheduled to the General Optical Council (Registration and Enrolment Rules) Order of Council 1977(**3**))the tables shown in the Appendix shall be substituted by the following:

EXPLANATORY NOTE

(This note is not part of the Order)

The rules approved by this Order increase with effect from 31st March 2003 the fees payable to the General Optical Council by ophthalmic and dispensing opticians and bodies corporate carrying on business as opticians for registration, enrolment or retention in, restoration to and transfer within the register of opticians. The fees were last fixed with effect from 1st April 2002 and have been increased by 9.5 per cent.

This Order also revokes a previous Order of Council which becomes spent on the revocation of rules which are scheduled to it.
